## INTRODUCTION

This document is a Consent Agreement regarding Tammy K. Boothby's license to practice registered professional nursing in the State of Maine. The parties enter into this Agreement pursuant to 10 M.R.S.A. § 8003(5)(A-1)(1), § 8003(5)(B) and 32 M.R.S.A. § 2105-A(1-A)(A). The parties to this Consent Agreement are Tammy K. Boothby ("Licensee"), Maine State Board of Nursing ("Board") and the Office of the Attorney General, State of Maine. An informal conference was held on February 27, 2004. The parties reached this Agreement on the basis of information submitted by Sisters of Charity Health System, St. Mary's Regional Medical Center, Lewiston, Maine by letter dated April 18, 2003.

## **FACTS**

- 1. Tammy K. Boothby has been a registered professional nurse licensed to practice in Maine since 2000.
- 2. Tammy K. Boothby has been employed at St. Mary's Regional Medical Center as a full time registered professional nurse since February 25, 2002 and was assigned to the Adult Psychiatric Unit. In March of 2003, Ms. Boothby was found sleeping while on duty for which she was suspended for 3 work days.

## **AGREEMENT**

- 3. Tammy K. Boothby agrees and understands that her conduct in the above stated facts constitutes grounds for discipline under Title 32 M.R.S.A. § 2105-A(2)(F), (2)(H) and Chapter 4.1.A.6. and Chapter 4.3.F. Tammy K. Boothby is hereby **WARNED** for unprofessional conduct and for failing to take appropriate action or follow policies and procedures in a practice situation designed to safeguard the patient.
- 4. Tammy K. Boothby understands that this Consent Agreement imposes discipline regarding her license to practice registered professional nursing in the State of Maine. Ms. Boothby understands that she does not have to execute this Consent Agreement and that she has the right to consult with an attorney before entering into this Consent Agreement.

I UNDERSTAND THAT THIS CONSENT AGREEMENT CONTAINS THE ENTIRE AGREEMENT AND THERE IS NO OTHER AGREEMENT OF ANY KIND.
