SUMMARY ORDER

Dear Mr. Dove:

The Disciplinary Committee of the Kansas State Board of Nursing (KSBN) has reviewed your application materials. It is the decision of the Board that your reinstatement application to practice nursing as a registered nurse in Kansas is denied. This denial is based upon the following:

FINDINGS OF FACT

- (a) On or about 3/18/2004 a Default Order revoking applicant's license was entered in case number 02-691-5. The following findings were made pursuant to that Default Order.
 - '5. Respondent applied for reinstatement on 7/12/02. The respondent did not report that a disciplinary action had been taken in Colorado on his nurse license. The Colorado Board of Nursing suspended his nursing license on 6/4/02 due to diversion and use of Demerol at the hospital where he was employed on or about 2/10/02. The Colorado license was relinquished 11/15/02.
 - Respondent failed to disclose employment as a nurse in Colorado on the reinstatement application of 7/12/02.
 - On or about 10/13/02 respondent was escorted by the police to the Emergency Dept. of Wesley Medical Center, Wichita, Kansas. He was found with syringes of Demerol. He admitted to Demerol use by injecting wasted narcotics. He was terminated for diversion of Demerol from the hospital.
 - On 9/25/03 respondent mailed his license card to the KSBN, noting 'I am voluntarily surrendering my nursing license for Kansas....'
 - Respondent has violated the Kansas Nurse Practice Act as follows: COUNT 1: K.S.A. 65-1120 (a)(1) To be guilty of fraud or deceit in practicing nursing or in procuring or attempting to procure a license to practice nursing; COUNT 2: K.S.A. 65-1120(a)(6), unprofessional conduct, by drug
 - COUNT 2: K.S.A. 65-1120(a)(6), unprofessional conduct, by drug diversion K.A.R. 60-3-110(n);

COUNT 3: K.S.A. 65 1120(a)(4) to be unable to practice with skill and safety due to current abuse of drugs or alcohol; COUNT 4: K.S.A. 65-1120(a)(8)to have a license to practice nursing as a registered nurse or as a practical nurse denied, revoked, limited or suspended, or to be publicly or privately censured, by a licensing authority of another state"

(b) On or about 9/30/2005 applicant submitted an application for reinstatement of his license to practice nursing in the state of Kansas.

CONCLUSIONS OF LAW

- 2. Pursuant to K.S.A. 65-1120(a), the Kansas State Board of Nursing may deny, revoke, limit or suspend any license, certificate of qualification or authorization to practice nursing as a registered professional nurse, as a licensed practical nurse, as an advanced registered nurse practitioner or as a registered nurse anesthetist that is issued by the board or applied for under this act or may publicly or privately censure a licensee or holder of a certificate of qualification or authorization, if the applicant, licensee or holder of a certificate of qualification or authorization is found to have violated the Nurse Practice Act. The above fact findings establish evidence that the applicant violated the following provisions of the Nurse Practice Act:
 - (a) K.S.A.65-1120(a)(1), to be guilty of fraud or deceit in practicing nursing or in procuring or attempting to procure a license to practice nursing.
 - (b) K.S.A. 65–1120(a)(6), unprofessional conduct by K.A.R. 60-3-110 (n), diverting drugs, supplies, or property of any patient or agency.
 - (c) K.S.A. 65-1120(a)(4), to be unable to practice with skill and safety due to current abuse of drugs or alcohol.
 - (d) K.S.A. 65-1120(a)(8), to have a license to practice nursing as a registered nurse or as a practical nurse denied, revoked, limited or suspended, or to be publicly or privately censured, by a licensing authority of another state, agency, or territory.
- 3. K.S.A. 77-511(a)(2)(A) of the Kansas Administrative Procedure Act authorizes the use of summary proceedings by a state agency when denying an application in whole or in part.
- 4. Your conduct described herein violates the Kansas Nurse Practice Act.
- 5. The role of the Kansas State Board of Nursing is to protect citizens of Kansas.
- 6. If you wish to dispute this matter, contact the Board immediately by following the procedure for requesting a hearing. A copy of your application will be sent to you upon request.
- 7. Pursuant to K.S.A. 77-537, this decision, which is called a Summary Order, is subject to your request for a hearing. If you desire a hearing, you must submit or direct a written request for hearing to:

PROPOSED DEFAULT ORDER REVOKING LICENSE

NOW ON THIS March, 2004, petitioner appears by disciplinary counsel, Betty Wright, for a pre-hearing conference on the petition. Respondent does not appear.

Wherefore, the hearing officer finds as follows:

- 1. Respondent was licensed as a R.N. through 1/31/04. The board has jurisdiction over this matter.
- Petitioner sent a copy of the petition and notice of this hearing to respondent's last known address and service is proper.
- 3. Petitioner moves for issuance of a proposed default order revoking the respondent's license.
- The petition is hereby granted and incorporated into this order as if set forth herein.
 Respondent violated the Nurse Practice Act as alleged in the petition.
- Per petitioner's request, respondent's license to practice nursing is revoked. Respondent may not
 practice nursing in Kansas. Respondent is to mail the license card to the board immediately.
- 6. Respondent shall pay the costs of the action of \$70.
- 7. Disciplinary counsel shall mail a copy of this order to respondent's last known address.
