PROPOSED DEFAULT ORDER TO DENY LICENSE

NOW ON THIS day of January, 2016, petitioner, the Kansas State Board of Nursing, appears by disciplinary counsel, Michael R. Fitzgibbons, Assistant Attorney General, for a Hearing on the Petition. Respondent does not appear.

Wherefore, the Presiding Officer finds as follows:

- 1. Respondent is licensed to practice nursing in Kansas. The Kansas State Board of Nursing has jurisdiction over the Respondent and the subject matter of this action.
- 2. Respondent was sent a copy of the petition and notice of this hearing to respondent's last known address and service is proper. Respondent does not appear.
- 3. Petitioner moves for issuance of a proposed default order denying respondent's license. The petitioner's request is granted by default pursuant to K.S.A. 77-520.
- 4. The petition is hereby granted and incorporated into this order as if set forth herein.

 Respondent violated the Nurse Practice Act as alleged in the petition.
- 5. Per Petitioner's request, Respondent's request to license to practice nursing is denied. Respondent may not practice nursing in Kansas.
- 6. Costs of the action of \$100 are assessed to respondent to be paid to the board by cash or money order within 30 days of the effective date of this order.
- 7. Respondent shall immediately forward his or her original Kansas nursing license to the Kansas State Board of Nursing.

- 8. This Proposed Default Order shall become effective seven days after service or ten days after mailing of this order unless the Respondent files a written motion with the Board stating why the Proposed Default Order should be vacated and the order is then vacated.
- 9. If this Proposed Default Order becomes effective, the Respondent's request for administrative hearing is dismissed pursuant to K.S.A. 77-520(d).
- 10. Disciplinary counsel shall mail a copy of this proposed default order to respondent's last known address.

Pursuant to K.S.A. 77-530, if neither party requests a review by the Kansas State Board of Nursing, then this initial order becomes final and binding on both parties on the 30th day following its service.

Pursuant to K.S.A. 77-531, if the initial order is served by mail, three days are added to the time limits set out above.

PETITION

COMES NOW the petitioner, the Kansas State Board of Nursing, by and through Assistant Attorney General assigned to the Board, Michael R. Fitzgibbons, and for its cause of action states that:

- Respondent, Richard Joseph Paulie, has a reinstatement application pending to practice 1. nursing in Kansas. The Board has jurisdiction over the respondent and the subject matter of this action.
- Respondent's address of record is 3304 Hughes Ave Parsons, Kansas 67357 2.
- After an investigation, the Board's investigative committee found reasonable grounds to 3. believe that the respondent violated the Kansas Nurse Practice Act, K.S.A. 65-1120, and referred this matter for further proceedings.
- The Kansas State Board of Nursing has the authority under K.S.A. 74-1106 et seq. to 4. examine, license and renew license for duly qualified applicants and may limit, deny, suspend or revoke a license or authorization to practice nursing, may issue a public or private censure and levy administrative fines consistent with K.S.A. 74-1110, if a violation of K.S.A. 65-1120(a) is established.

FACTS COMMON TO ALL COUNTS

- The facts below are common to all counts: 5.
 - (a) It is alleged that applicant failed to document in his application that he had been employed at Prairie Mission Retirement Village, Saint Paul, Kansas from the 5th of April, 2013 to the 18th of July, 2013.

- (b) Applicant was terminated from this employment due to performance issues.
- (c) Applicant had multiple practice error while employed at this facility.
- (d) Applicant's license lapsed on the 31st day of May 2014
- (e) Licensee/Applicant submitted a reinstatement application on the 11th day of June 2015.
- (f) Applicant failed to notify KSBN of change of address

VIOLATIONS

6. Respondent has violated the Kansas Nurse Practice Act as follows:

Count 1: K.S.A. 65 1120(a)(1) unprofessional conduct by fraud or deceit in practicing nursing.

Count 2: K.S.A. 65-1120 (e) (3) professional incompetence as defined as a pattern of practice or other behavior which demonstrates a manifest incapacity or incompetence to practice nursing

WHEREFORE, petitioner requests a finding that the respondent has violated the Nurse Practice Act, that respondent's reinstatement application to practice nursing in Kansas be denied, and that costs of this action be assessed to the respondent in the amount of \$100.00.
