**SUMMARY ORDER**

NOW ON THIS 25<sup>th</sup> day of January, 2016, THE ABOVE MATTER COMES BEFORE THE Kansas State Board of Nursing (Board) pursuant to authority granted to the Board by K.S.A. 65-1120. The Board hereby proposed to find facts and take disciplinary action against the renewal application of Licensee by way of Summary Order as provided by K.S.A. 77-537.

**FINDINGS OF FACT**

1. Licensee submitted a renewal application to practice nursing in the state of Kansas. The Board has jurisdiction over the Licensee and the subject matter of this action.
2. Licensee's address of record is 615 W. 5<sup>th</sup> Street Fort Scott, Kansas 66701-2205.
3. On or about 26th day of April, 2014, the Board received Licensee's renewal application to practice nursing in the State of Kansas.
4. Review of the Application and other information gathered by the Board revealed the following information upon which this action is based.
5. Licensee answered "no" to the question about whether he/she had obtained the 30 hours of Continuing Education (CNE) required for license renewal pursuant to K.S.A. 65-1117(a) and KAR 60-9-106(a).
6. Licensee failed to provide documentation showing that she had completed the CNE prior to completing her renewal application as required by K.S.A. 65-1117(A) and K.A.R. 60-9-106.

7. Licensee is not a first time renewal expiring within 30 months following licensure examination or a renewal expiring within 9 months of reinstatement or endorsement, either of which would be an exception to the requirement for CNE.
8. Despite the written instructions on the 16th day of May, 2014, telling the Licensee that the process could not be completed if the 30 hours of CNE was not obtained and again on the 10<sup>th</sup> day of June, 2014. Licensee failed to provide 30 hours of CNE as required within the time period required.
9. Licensee upon request has not submitted proof of the required 30 hours of CNE allegedly obtained prior to the online renewal application in order to qualify for renewal of the nursing license.

#### CONCLUSIONS OF LAW

1. Pursuant to K.S.A. 65-1117(a) and KAR 60-9-106(a) each Licensee for renewal of a Kansas nursing license shall submit proof of completion of 30 hours of CNE obtained within the prior licensing period.
2. Pursuant to K.S.A. 65-1120(a), the Kansas State Board of Nursing may deny, revoke, limit or suspend any license, certificate of qualification or authorization to practice nursing as a registered professional nurse , as a licensed practical nurse, as an advanced registered nurse practitioner or as a registered nurse anesthetist that is issued by the board or applied for under authorization, if the Licensee, licensee or holder of a certificate of qualifications or authorization is found to have violated the Nurse Practice Act. The above fact findings established evidence that the Licensee violated the following provisions of the Nurse Practice Act:
  - (a) K.S.A. 65-1120(a)(1), to be guilty of fraud or deceit in procuring or attempting to procure a license to practice nursing.
  - (b) K.S.A. 65-1120(a)(6), to be guilty of unprofessional conduct as defined by the rules and regulations of the Board, KAR 60-3-110(b) assuming duties and

responsibilities within the practice of nursing without making or obtaining adequate preparation or maintaining competency.

(c) K.S.A. 65-1120(a)(7) willfully violating any of the provisions of the Kansas Nurse Practice Act and K.S.A. 65-1117(A) and KAR 60-9-106 every licensee with an active nursing license shall submit with the renewal application evidence of satisfactory completion of a program of CNE as required by the Board which is 30 hours or CNE obtained with the prior licensing period.

- 3 Licensee's conduct described herein violated the Kansas Nurse Practice Act and renders the Licensee non-qualified for obtaining a renewal of his/her license.
- 4 K.S.A. 77-511(a)(2)(A) of the Kansas Administrative Procedure Act authorized by use of the summary proceedings does not violated any provision of law and the protection of the public interest does not require the state agency to give notice and opportunity to participate to persons other than the parties.
- 5 The role of the Kansas State Board of Nursing is to protect citizens of Kansas.

#### POLICY STATEMENT

1. Continuing Education is a mandate by the state legislature and is intended to build upon the educations and experiential bases of the nurse for the enhancement of practice, education, administration, and research or theory development to the end of improving the health of the public.
2. Truthfulness is a hallmark of the nursing profession and is required to ensure accurate communication of all nursing actions

#### **IT IS THEREFORE ORDERED BY THE KANSAS STATE BOARD OF NURSING THAT**

1. **Licensee's license to practice nursing in the state of Kansas is revoked.**
2. **Upon reinstatement in addition to the submission of the proper forms, fees and documentation of 30 hours of CNE, the Licensee will be required to**

**submit proof of completion of a course of CNE that teaches about the  
Kansas Nurse Practice Act.**

Pursuant to K.S.A. 77-537, the decision, which is called a Summary Order, is subject to your request for hearing. If you desire a hearing, you must submit or direct a **written** request for hearing to: Kansas State Board of Nursing, Legal Division, 900 SW Jackson, Suite 1051, Topeka, Kansas 66612-1230, (785) 296-4325. **THIS REQUEST MUST BE SUBMITTED WITHIN FIFTEEN (15) DAYS FROM THE DATE OF THIS ORDER.** If a hearing is not requested in the time and manner stated, this Summary Order becomes effective as a final order, without further notice, upon the expiration of the time for requesting a hearing.

Pursuant to K.S.A. 77-531, if the Summary Order is served by mail, three days are added to the time limits set out above.
