NUNC PRO TUNC PROPOSED DEFAULT ORDER TO REVOKE LICENSE

NOW ON THIS day of April, 2011, petitioner, the Kansas State Board of Nursing, appears by disciplinary counsel, Alma A. Heckler, for a Hearing on the Petition. Respondent does not appear.

Wherefore, the Presiding Officer finds as follows:

- Respondent is licensed to practice nursing in Kansas through 10/31/2011. The Kansas State Board of Nursing has jurisdiction over the Respondent and the subject matter of this action.
- 2. Respondent was sent a copy of the petition and notice of this hearing to respondent's last known address and service is proper. Respondent does not appear.
- 3. Petitioner moves for issuance of a proposed default order revoking respondent's license. The petitioner's request is granted by default pursuant to K.S.A. 77-520.
- 4. The petition is hereby granted and incorporated into this order as if set forth herein. Respondent violated the Nurse Practice Act as alleged in the petition.
- Per Petitioner's request, Respondent's license to practice nursing is revoked.
 Respondent may not practice nursing in Kansas.
- 6. Costs of the action of \$70 are assessed to respondent to be paid to the board by cash or money order within 30 days of the effective date of this order.
- 7. Respondent shall immediately forward his or her original Kansas registered nurse license to the Kansas State Board of Nursing.

- 8. This Proposed Default Order shall become effective seven days after service or ten days after mailing of this order unless the Respondent files a written motion with the Board stating why the Proposed Default Order should be vacated and the order is then vacated.
- 9. If this Proposed Default Order becomes effective, the Respondent's request for administrative hearing is dismissed pursuant to K.S.A. 77-520(d).
- 10. Disciplinary counsel shall mail a copy of this proposed default order to respondent's last known address.

PETITION

COMES NOW the petitioner, the Kansas State Board of Nursing, by and through
Assistant Attorney General assigned to the Board, Alma A. Heckler, and for its cause of action
states that:

- 1. Respondent, Nicole H. Sloan, is licensed to practice nursing in Kansas through 10/31/2011. The Board has jurisdiction over the respondent and the subject matter of this action.
- 2. Respondent's address of record is 226 South Hydraulic Street, Apt. 8, Wichita, KS 67211-1966.
- 3. After an investigation, the Board's investigative committee found reasonable grounds to believe that the respondent violated the Kansas Nurse Practice Act, K.S.A. 65-1120, and referred this matter for further proceedings.
- 4. The Kansas State Board of Nursing has the authority under K.S.A. 74-1106 et seq. to examine, license and renew license for duly qualified applicants and may limit, deny, suspend or revoke a license or authorization to practice nursing, may issue a public or private censure and levy administrative fines consistent with K.S.A. 74-1110, if a violation of K.S.A. 65-1120(a) is established.

FACTS COMMON TO ALL COUNTS

- 5. The facts below are common to all counts:
- (a) Respondent is licensed in Nebraska and Kansas. While the respondent was employed by the Nebraska Heart Institute in Lincoln, Nebraska, respondent had a positive urine

drug screen on or about July 25, 2009 for amphetamines, Oxycodone, and Oxymorphone.

Respondent had a valid prescription for the amphetamines but not for the Oxycodone and Oxymorphone. Respondent was suspended and then terminated from her employment at the facility on or about August 6, 2009.

- (b) Respondent failed to report a February 2009 Driving Under the Influence (DUI) conviction or the termination of her employment at the Nebraska Heart Institute on or about August 6, 2009 for a positive drug screen for controlled substances she used without a prescription. Respondent was required to report the conviction and employment termination within thirty (30) days to the Nebraska Nursing Board. Respondent's nursing license in Nebraska was revoked on or about June 24, 2010.
- (c) Respondent was originally licensed in Kansas on 7/17/06. Respondent failed to report her misdemeanor criminal conviction of DUI within thirty (30) days as required by Kansas statute to the Kansas Nursing Board. Respondent also failed to report the revocation of her Nebraska nursing license on June 24, 2010 to the Kansas Nursing Board.

VIOLATIONS

- 6. Respondent has violated the Kansas Nurse Practice Act as follows:
- Count 1: K.S.A. 65-1120(a)(6), unprofessional conduct, by drug diversion K.A.R. 60-3-110(n);
- Count 2: K.S.A. 65 1120(a)(4) to be unable to practice with skill and safety due to current abuse of drugs or alcohol;
- Count 3: K.S.A. 65 1120(a)(6), unprofessional conduct by inaccurately recording, falsifying, or altering any record of a patient or agency or of the board; K.A.R. 60-3-110(d).
- Count 4: K.S.A. 65-1120(a)(8), to have a license to practice nursing as a registered nurse or as a practical nurse denied, revoked, limited or suspended, or to be publicly or privately censured, by a licensing authority of another state, agency of the United States government,

territory of the United States or country or to have other disciplinary action taken against the applicant or licensee by a licensing authority of another state, agency of the United States government, territory of the United States or country.

Count 5: K.S.A. 65-1120(a)(2) "to have been guilty of a felony or to have been guilty of a misdemeanor involving an illegal drug offense unless the applicant or licensee establishes sufficient rehabilitation to warrant the public trust..."

WHEREFORE, petitioner requests a finding that the respondent has violated the Nurse Practice Act, that respondent's license to practice nursing in Kansas be revoked, and that costs of this action be assessed to the respondent in the amount of \$70.00.
