INITIAL ORDER

On the 23rd of November, 2005, the above-captioned matter comes on for hearing before the Office of Administrative Hearings. The petitioner, the Kansas State Board of Nursing, appears by disciplinary counsel, Betty Wright. The respondent, Sarah Boos, appears in person. The prehearing and hearing in this matter were held by conference call.

FIINDINGS OF FACT

1. The respondent has applied for a license to practice nursing with the Kansas State Board of Nursing.
2. The respondent's address is 1405 Cedar Ridge Circle, Raymore, Missouri. Notice of Prehearing Conference was sent October 19, 2005, service is proper.
3. Pursuant to K.S.A. 77-516, the prehearing was converted to a hearing on November 23, 2005.
4. The respondent was first licensed to practice nursing in the State of Kansas in January 1990. She was endorsed from the State of Missouri. The respondent was licensed to practice nursing in Missouri in 1987.
5. In 1992, the respondent took Demeral from her work site and injected it into herself when she was off duty. The respondent was referred to the [REDACTED]. The respondent successfully completed [REDACTED].
6. In the year 2000, the respondent diverted Percocet from a patient while at work and consumed it when she was off duty. The respondent went into in-patient treatment for addiction for three (3) days and completed extensive out-patient treatment for addiction with Menningers. The respondent was once again placed with [REDACTED]. The respondent successfully completed [REDACTED] in 2003.
7. In 2004, the respondent allowed her Kansas license to practice nursing lapse.
8. In January 2005, the respondent diverted Morphine out of a sharps container. She also diverted needles and syringes from her employer. The respondent

injected the Morphine into herself while off duty. The next day, after completing work, the respondent was summoned by her employer to provide a urine sample. The urine analysis was positive for Morphine.

9. The respondent currently has an action pending against her license in the State of Missouri. [REDACTED]

10. The respondent's psychiatrist, Kenneth Sonnenschein, MD, and the respondent's out-patient therapist, Ann Schmidt, LSCSW have both written letters of recommendation for the respondent indicating that she is in recovery. Carol Dickerson, ARNP, works with the respondent. Ms. Dickerson indicates that she has not seen any behaviors from the respondent that would concern her. She believes the respondent takes care of her patients well and is an asset to her work facility.

CONCLUSIONS OF LAW

1. Pursuant to the Kansas Nurse Practice Act, at K.S.A. 65-1120(a)(6), the Kansas Board of Nursing may deny an applicant a license to practice nursing if it is found that the individual is guilty of unprofessional conduct.
 2. Kansas Administrative Regulation (K.A.R.) 60-3-110 addresses unprofessional conduct. K.A.R 30-3-110(n) defines an act of diverting drugs, supplies, or property of any patient or agency as unprofessional conduct. In the case at hand, as recently as January 2005 the respondent has diverted drugs and supplies from an agency for her personal use.
 3. Each time the respondent has relapsed into addictive behavior, she has diverted drugs and supplies from a patient or employer.
 4. The Presiding Officer finds that the respondent has violated the Kansas Nurse Practice Act by acts of unprofessional conduct as defined above. Pursuant to K.S.A. 65-1120, the Board has properly denied the respondent's application to practice nursing in the State of Kansas.
 5. Further, pursuant to K.S.A. 65-1120(d) costs of \$70.00 are hereby assessed to the respondent.
