SUMMARY ORDER

Now this Odd day of Mursing (Board), 2015, the above matter comes before the Kansas State Board of Nursing (Board) pursuant to authority granted to the Board by K.S.A. 65-1120. The Board hereby proposes to find facts and take disciplinary action against the applicant, Aaryn Brown, by way of Summary Order as provided by K.S.A. 77-537.

- 1. Applicant filed an applicantion to endorse on or about August 17, 2015. The Board has jurisdiction over the respondent and the subject matter of this action.
- 2. Applicant's address of record is14118 Skyline Drive, Alexander AR 72002.
- 3. The role of the Kansas State Board of Nursing is to protect citizens of Kansas.
- 4. The Kansas State Board of Nursing has the authority under K.S.A. 74-1106 et seq. to examine, license and renew license for duly qualified applicants and may limit, deny, suspend or revoke a license or authorization to practice nursing, may issue a public or private censure and levy administrative fines consistent with K.S.A. 74-1110, if a violation of K.S.A. 65-1120(a) is established.
- 5. After an investigation, the Board's investigative committee found reasonable grounds to believe that the Applicant failed to meet the appropriate licensure requirements of the Kansas Nurse Practice Act, K.S.A. 65-1120, and referred this matter for further proceedings.
- 6. K.S.A. 77-511(a)(2)(A) of the Kansas Administrative Procedure Act authorizes the use of summary proceedings by a state agency if the use of summary proceedings does not violate any provision of law, the protection of the public interest does not require the state agency to give notice and an opportunity to participate to persons other than the parties, and the state agency believes in good faith, after investigation of the facts, that the allegations will be supported to the applicable standard of proof.

FINDING OF FACTS

- 7. (a) Applicant has not produced her school transcript.
- (b) Applicant wrote two checks totaling \$123.00 for payment of her RN application fee and the fingerprint fee, both of which were not honored by Applicant's bank.
- (c) Demand was made of the Applicant to make good on these checks and Applicant has failed to do so.

8. Applicant's actions are contrary to the Kansas Nurse Practice Act as follows:

Count 1: K.S.A. 65-1115 and K.A.R. 60-3-105, failure to comply with the requirements for licensure as a professional nurse.

IT IS THEREFORE ORDERED BY THE KANSAS STATE BOARD OF NURSING THAT

- 1. Applicant's endorsement is denied.
- 2. Licensee shall not practice nursing in the state of Kansas.
- 3. Licensee shall pay \$70.00 costs of this action to the Board within thirty (30) days of the effective day of this Order.

Pursuant to K.S.A. 77-537, this decision, which is called a Summary Order, is subject to your request for a hearing. If you desire a hearing, you must submit or direct a written request for hearing to: Kansas State Board of Nursing, Legal Division, 900 SW Jackson, Suite 1051, Topeka, Kansas 66612-1230, (785) 296-4325. THIS REQUEST MUST BE SUBMITTED WITHIN FIFTEEN (15) DAYS FROM THE DATE OF THIS ORDER. If a hearing is not requested in the time and manner stated, this Summary Order becomes effective as a final order, without further notice, upon the expiration of the time for requesting a hearing. If a hearing is requested, the prior issuance of a summary order shall not affect the burden of proof. Pursuant to K.S.A. 77-531, if the Summary Order is served by mail, three days are added to the time limits set out above.
