PROPOSED DEFAULT ORDER TO REVOKE LICENSE

NOW ON THIS 26th day of August, 2014, petitioner, the Kansas State Board of Nursing; appears by disciplinary counsel, Alma A. Heckler, Assistant Attorney General, for a Hearing on the Petition. Respondent does not appear.

Wherefore, the Presiding Officer finds as follows:

1. Respondent is licensed to practice nursing as an RN in Kansas through 1/31/2015 and was licensed to practice nursing at the time of the misconduct alleged in the petition. The Kansas State Board of Nursing has jurisdiction over the Respondent and the subject matter of this action.
2. Respondent was sent a copy of the petition and notice of this hearing to respondent's last known address and service is proper. Respondent failed to answer the petition. Respondent does not appear at prehearing today. Respondent did not file a motion for a continuance in writing as required in the notice of hearing prior to the prehearing set for today at 9:00 am.
3. Petitioner moves for issuance of a proposed default order revoking respondent's RN license. The petitioner's request is granted by default pursuant to K.S.A. 77-520.
4. The petition to revoke is hereby granted and incorporated into this order as if set forth herein. Respondent violated the Nurse Practice Act as alleged in the petition.
5. Per Petitioner's request, Respondent's license to practice nursing is revoked. Respondent may not practice nursing in Kansas.

6. Costs of the action are assessed to respondent to include, payment of the renewal fee of \$60.00, the returned checks service fee of \$30.00, and the \$70.00 costs of this action. The total amount assessed to the Respondent is in the amount of \$160.00.
7. Respondent shall immediately forward her original Kansas nursing certificate and any license cards in his or her possession to the Kansas State Board of Nursing.
8. This Proposed Default Order shall become effective seven days after service or ten days after mailing of this order unless the Respondent files a written motion with the Board stating why the Proposed Default Order should be vacated and the order is then vacated.
9. If this Proposed Default Order becomes effective, the Respondent's request for administrative hearing is dismissed pursuant to K.S.A. 77-520(d).
10. Disciplinary counsel shall mail a copy of this proposed default order to respondent's last known address.

IT IS SO ORDERED.





NOTICE

Pursuant to K.S.A. 77-520(b) within seven (7) days after service of a proposed default order, the party against whom the default order was issued may file a written motion requesting that the proposed default order be vacated and stating the grounds relied upon.

Pursuant to K.S.A. 77-520(c) the proposed default order shall become effective after expiration of the time within which the party may file a written motion under subsection (b) unless a written motion to vacate the order is filed with the agency within such time. The motion to vacate shall be mailed or personally delivered to: State Board of Nursing - Legal Division, Landon State Office Building, 900 SW Jackson, Ste 1051, Topeka, KS 66612-1230.

Pursuant to K.S.A. 77-531, if the default order is served by mail, three days are added to the time limits set out above.



PETITION

COMES NOW the petitioner, the Kansas State Board of Nursing, by and through Assistant Attorney General assigned to the Board, Alma A. Heckler, and for its cause of action states that:

1. Respondent, Yvonne Denise Williams filed an online renewal application on or about January 28, 2013. Respondent is licensed and her license does not lapse until 1/31/2015. The Board has jurisdiction over the respondent and the subject matter of this action.
2. Respondent's address of record is 2600 SE Ohio Ave., Topeka, Kansas 66605-2970.
3. After an investigation, the Board's investigative committee found reasonable grounds to believe that the respondent violated the Kansas Nurse Practice Act, K.S.A. 65-1120, and referred this matter for further proceedings.
4. The Kansas State Board of Nursing has the authority under K.S.A. 74-1106 et seq. to examine, license and renew license for duly qualified applicants and may limit, deny, suspend or revoke a license or authorization to practice nursing, may issue a public or private censure and levy administrative fines consistent with K.S.A. 74-1110, if a violation of K.S.A. 65-1120(a) is established.

FACTS

5. The Respondent in this case filed an online renewal application with the Board on or about January 28, 2013. The Respondent's online payment of \$60.00 was returned by the financial institution on 2/4/2013 as insufficient. Respondent has failed to pay the fees even

after a demand for payment was made in writing by the Board on June 10, 2014. Respondent has not met the minimum requirements of K.S.A. 65-1117 and K.S.A. 65-1118.

VIOLATIONS

6. Respondent has violated the Kansas Nurse Practice Act as follows:


Count 1: K.S.A.65-1120(a)(1), to be guilty of fraud or deceit in practicing nursing or in procuring or attempting to procure a license to practice nursing.

WHEREFORE, petitioner requests a finding that the Respondent has violated the Nurse Practice Act, payment of the renewal fee of \$60.00, the returned checks service fee of \$30.00, and for respondent to be assessed the \$70.00 costs of this action. The total amount assessed to the Respondent is in the amount of \$160.00. Additionally, Petitioner requests that the Respondent's license be revoked for her failure to pay the renewal fee.
