DEFAULT ORDER SUSPENDING LICENSE

NOW ON THIS 6th day of April, 2005, petitioner appears by disciplinary counsel, Betty Wright, for a Hearing on the Petition. Respondent does not appear.

Wherefore, the hearing officer finds as follows:

1. Respondent was licensed through 2/28/2005 as an L.P.N. The board has jurisdiction over this matter.
2. Petitioner sent a copy of the petition and notice of this hearing to respondent's last known address, service is proper.
3. Petitioner moves for issuance of a proposed default order suspending license.
4. The petitioner's request is granted by default.
5. The petition is hereby granted and incorporated into this order as if set forth herein.
6. Respondent violated the Nurse Practice Act by violating:
K.S.A. 65-1120(a)(4), to be unable to practice with skill and safety due to current abuse of drugs or alcohol.
K.S.A. 65-1120(a)(6), unprofessional conduct, by drug diversion (K.A.R. 60-3-110(n).
K.S.A. 65-1120(a)(6), to be guilty of unprofessional conduct by failing to take appropriate action or to follow policies and procedures in the practice situation designed to safeguard the patient; K.A.R. 60-3-110(c).
7. Costs of the action of \$70 are assessed to respondent to be paid to the board by cash or money order within 30 days of the effective date of this order.
8. Respondent shall forward original Kansas L.P.N. license immediately to the Kansas State Board of Nursing.
9. Disciplinary counsel shall mail a copy of this order to respondent's last known address.
