SUMMARY ORDER

Dear Ms. Atwater-Vera:

The Investigative Committee of the Kansas State Board of Nursing (KSBN) has reviewed your application materials. It is the decision of the Board that your reinstatement application to practice nursing as a licensed practical nurse in Kansas is denied. This denial is based upon the following:

FINDINGS OF FACT

1. (a) Respondent submitted an application to the Board for reinstatement as a licensed practical nurse in the State of Kansas on August 14, 2006.

(b) Respondent had an LPN license No. 19490-091 and let it lapse on 9/30/2005. An investigative file was opened after a report was received that alleged the respondent displayed odd behavior at work and when asked to complete a UDS, she tested positive for cocaine and amphetamines. The date of violation was 5/31/2005. The respondent was referred to Kansas Nurses Assistance Program (KNAP) but the respondent chose to let her license lapse rather than enter KNAP. When respondent filed the reinstatement, she contacted the Board Investigator Karen Peschka, and told Ms. Peschka she had never entered KNAP and she would now self-refer to KNAP. Respondent stated she had no intention of working as a nurse but wanted to be re-licensed in case she changed her mind.

[REDACTED] The respondent has failed to prove she is safe to practice at this time.

CONCLUSIONS OF LAW

2. Pursuant to K.S.A. 65-1120(a), the Kansas State Board of Nursing may deny, revoke, limit or suspend any license, certificate of qualification or authorization to practice nursing as a registered professional nurse, as a licensed practical nurse, as an advanced registered nurse practitioner or as a registered nurse anesthetist that is issued by the board or applied for under this act or may publicly or privately censure a licensee or holder of a certificate of qualification or authorization, if the applicant, licensee or holder of a certificate of qualification or authorization is

found to have violated the Nurse Practice Act. The above fact findings establish evidence that the applicant violated the following provisions of the Nurse Practice Act:

(a) Count 1: K.S.A. 65-1120(a)(4), to be unable to practice with skill and safety due to current abuse of drugs or alcohol.

(b) Count 2: K.S.A. 65-1120(a)(6), unprofessional conduct by K.A.R. 60-3-110 (s) failing to complete the requirements of the impaired provider program of the board.

3. K.S.A. 77-511(a)(2)(A) of the Kansas Administrative Procedure Act authorizes the use of summary proceedings by a state agency when denying an application in whole or in part.

4. Your conduct described herein violates the Kansas Nurse Practice Act.


5. The role of the Kansas State Board of Nursing is to protect citizens of Kansas.

6. If you wish to dispute this matter, contact the Board immediately by following the procedure for requesting a hearing. A copy of your application will be sent to you upon request.
