**SUMMARY ORDER**

The above matter comes before the Kansas State Board of Nursing (Board) pursuant to authority granted to the Board by K.S.A. 65-1120. The Board hereby proposes to find facts and take disciplinary action against the nurse license of Rhonda Glisar, (Licensee) by way of Summary Order as provided by K.S.A. 77-537.

1. a. Licensee is licensed to practice nursing in the state of Kansas. The Board has jurisdiction over the Licensee and the subject matter of this action.

b. Licensee's address of record is 3903 W Angel Street, Wichita KS 67217.

2. The role of the Kansas State Board of Nursing is to protect citizens of Kansas.

3. Pursuant to K.S.A. 65-1120(a), the Kansas State Board of Nursing may deny, revoke, limit or suspend any license, certificate of qualification or authorization to practice nursing as a registered professional nurse, as a licensed practical nurse, as an advanced registered nurse practitioner or as a registered nurse anesthetist that is issued by the board or applied for under this act or may publicly or privately censure a licensee or holder of a certificate of qualification or authorization, if the applicant, licensee or holder of a certificate of qualification or authorization is found to have violated the Nurse Practice Act. Pursuant to K.S.A. 74-1110 the Kansas State Board of Nursing may also assess a civil fine not to exceed \$1,000.00 for the first violation of a law or rule and regulation applicable to the practice for which such person has been granted a license.

4. After an investigation, the Board's investigative committee found reasonable grounds to believe that the Applicant violated the Kansas Nurse Practice Act, K.S.A. 65-1120, and referred this matter for further proceedings.

5. K.S.A. 77-511(a)(2)(A) of the Kansas Administrative Procedure Act authorizes the use of summary proceedings by a state agency if the use of summary proceedings does not violate any provision of law, the protection of the public interest does not require the state agency to give notice and an opportunity to participate to persons other than the parties, and the state agency believes in good faith, after investigation of the facts, that the allegations will be supported to the applicable standard of proof.

**FINDINGS OF FACT**

6. (a) On or about September 18, 2015 a patient complained that licensee's daughter was telling others that the patient was receiving treatment at a certain facility. The daughter stated she knew the patient was receiving such treatment because her mother, the above licensee, who worked at that facility, had shared this information with the daughter.

(b) Licensee was then terminated by that facility for violation of patient confidentiality.

(c) After Licensee's termination, the facility discovered emails between the licensee at work and her daughter, which revealed that the licensee was assisting the daughter in the selling of prescription medications. The licensee subsequently admitted to an investigator for the Kansas State Board of Nursing that she had given her daughter her (licensee's) medication for the daughter to sell for profit to unknown persons.

### VIOLATIONS


7. The above fact findings establish evidence that the Licensee violated the following provisions of the Kansas Nurse Practice Act:

- (a) K.S.A. 65-1120(a)(6) and K.A.R. 60-3-110, to be guilty of unprofessional conduct as defined by rules and regulations of the board; to wit: violating the confidentiality of information or knowledge concerning any patient.
- (b) K.S.A. 65-1120(a)(3), to have committed acts of professional incompetency.

### **IT IS THEREFORE ORDERED BY THE KANSAS STATE BOARD OF NURSING THAT**

- 1. Licensee's license is suspended.**
- 2. Licensee shall not practice nursing in the state of Kansas.**



THIS REQUEST MUST BE SUBMITTED WITHIN FIFTEEN (15) DAYS FROM THE DATE OF THIS ORDER. If a hearing is not requested in the time and manner stated, this Summary Order becomes effective as a final order, without further notice, upon the expiration of the time for requesting a hearing. If a hearing is requested, the prior issuance of a summary order shall not affect the burden of proof. Pursuant to K.S.A. 77-531, if the Summary Order is served by mail, three days are added to the time limits set out above.


**FINAL ORDER NOTICE OF RIGHTS**
