ADDENDUM TO CONSENT AGREEMENT

NOW ON THIS 5th day of September, 2014, the Kansas State Board of Nursing, represented by Assistant Attorney General, Michael R. Fitzgibbons, and the Licensee, hereby enter into this Addendum to the Initial Order dated 28th August, 2013

BACKGROUND AND PURPOSE

1. This licensee stipulates to the following facts:
 - a. According to the report, it is alleged that your pre-employment urine drug screen for employment at the Kansas Masonic Home in Wichita, Kansas was positive for Cannabinoids.
 - b. This incident allegedly occurred or about June 4th, 2010.
 - c. KSBN referred this licensee to KNAP on April 4th, 2011 after locating a good address for this licensee.
 - d. On June 14th, 2011, Respondent entered KNAP on a one year Extended Evaluation program.
 - e. On July 11th, 2011, this licensee tested positive for cannabinoid and this incident is considered a relapse.
 - f. This licensee's time with KNAP programs proceeds to three (3) year program from the date of relapse.
 - g. On the 17th of August, 2011, your case with KNAP was closed due to non compliance for failure to check in for UDS.

- h. KSBN again referred this licensee to KNAP on the 23rd of September, 2011 for his final chance to stay in compliance.
- i. On the 26th of October, 2011, the KNAP case was again closed for non compliance.
- j. Licensee entered into a Consent Agreement with the Board on the 28th day of August, 2013 and was referred back to KNAP.
- k. Licensee failed to submit his 12 step attendance on the 9th day of December, 2013.
- l. Licensee failed to attend monthly monitoring meeting in February, 2014
- m. Licensee's KNAP case was closed for non compliance issues on the 5th day of June, 2014.
- n. This closure is a violation of the Kansas Nurse Practice Act for failure to complete the impaired provider program K.S.A. 65-1120(a)(6).

2 The parties agree that this Addendum is made part of, and incorporated into the Initial Order 28th day of August, 2013. The parties further agree that this Addendum and the Initial Order together, constitute the Initial Order.

3 Licensee has the right to hearings and the right to seek review of the findings from the hearings in accordance with the Kansas Administrative Procedure Act and the Act for Judicial Review and Civil Enforcement of agency actions. Licensee is waiving those rights and knowingly and voluntarily entering into this agreement instead of proceeding to these hearings.

4 Licensee understands that pursuant to K.S.A. 77-515, Licensee may be represented at licensee's expense by, an attorney during these proceedings.


5 Licensee is licensed to practice nursing as a nurse in Kansas through February 2016. The Kansas State Board of Nursing has jurisdiction over the Licensee and the subject matter of this action. Licensee has to this point, adhered to the requirements and conditions of the Consent Agreement and Final Order.

6 Based upon this agreement, and pursuant to the disciplinary remedies available in K.S.A. 65-1120, the parties agree that licensee will re enter KNAP and stay compliant.


