appears by disciplinary counsel, Alma A. Heckler, for a Hearing on the Petition. Respondent does not appear.

Wherefore, the Presiding Officer finds as follows:

1. Respondent is licensed to practice nursing in Kansas through 4/30/2009. The Kansas

State Board of Nursing has jurisdiction over the Respondent and the subject matter of this action.

2. Petitioner sent a copy of the petition and notice of this hearing to respondent's last

known address and service is proper. Respondent does not appear.

3. Petitioner moves for issuance of a proposed default order revoking respondent's license.

The petitioner's request is granted by default pursant to K.S.A. 77-520.

4. The petition is hereby granted and incorporated into this order as if set forth herein.

Respondent violated the Nurse Practice Act as alleged in the petition.

5. Per Petitioner's request, Respondent's license to practice nursing is revoked.

Respondent may not practice nursing in Kansas.

6. Costs of the action of \$70 are assessed to respondent to be paid to the board by cash or money order within 30 days of the effective date of this order.

7. Respondent shall immediately forward his or her original Kansas licensed practical nurse license to the Kansas State Board of Nursing.

8. This Proposed Default Order shall become effective seven days after service or ten days

afer mailing of this order unless the Respondent files a written motion with the Board stating

why the Proposed Default Order should be vacated and the order is then vacated.

9. If this Proposed Default Order becomes effective, the Respondent's request for

administative hearing is dismissed pursuant to K.S.A. 77-520(d).

10. Disciplinary counsel shall mail a copy of this proposed default order to respondent's last

known address.

Pursuant to K.S.A. 77-531, if the initial order is served by mail, three days are added to the time limits set out above.
