PROPOSED DEFAULT ORDER TO REVOKE LICENSE

NOW ON THIS Aday of August, 2011, petitioner, the Kansas State Board of Nursing, appears by disciplinary counsel, Alma A. Heckler, for a Hearing on the Petition.

Respondent does not appear.

Wherefore, the Presiding Officer finds as follows:

- Respondent is licensed to practice nursing in Kansas through 6/30/2012. The Kansas State Board of Nursing has jurisdiction over the Respondent and the subject matter of this action.
- 2. Respondent was sent a copy of the petition and notice of this hearing to respondent's last known address and service is proper. Respondent does not appear.
- Petitioner moves for issuance of a proposed default order revoking respondent's license.
 The petitioner's request is granted by default pursuant to K.S.A. 77-520.
- 4. The petition is hereby granted and incorporated into this order as if set forth herein.

 Respondent violated the Nurse Practice Act as alleged in the petition.
- Per Petitioner's request, Respondent's license to practice nursing is revoked.
 Respondent may not practice nursing in Kansas.
- 6. Costs of the action of \$70 are assessed to respondent to be paid to the board by cash or money order within 30 days of the effective date of this order.
- Respondent shall immediately forward his or her original Kansas licensed practical nurse
 temporary license to the Kansas State Board of Nursing.

- 8. This Proposed Default Order shall become effective seven days after service or ten days after mailing of this order unless the Respondent files a written motion with the Board stating why the Proposed Default Order should be vacated and the order is then vacated.
- 9. If this Proposed Default Order becomes effective, the Respondent's request for administrative hearing is dismissed pursuant to K.S.A. 77-520(d).
- 10. Disciplinary counsel shall mail a copy of this proposed default order to respondent's last known address.

PETITION

COMES NOW the petitioner, the Kansas State Board of Nursing, by and through
Assistant Attorney General assigned to the Board, Alma A. Heckler, and for its cause of action
states that:

- 1. Respondent, Rochelle M. Rodriguez, is licensed to practice nursing in Kansas through 6/30/2012. The Board has jurisdiction over the respondent and the subject matter of this action.
- Respondent's address of record is 4924 Dixie Court, Kansas City, KS 66106.
- 3. After an investigation, the Board's investigative committee found reasonable grounds to believe that the respondent violated the Kansas Nurse Practice Act, K.S.A. 65-1120, and referred this matter for further proceedings.
- 4. The Kansas State Board of Nursing has the authority under K.S.A. 74-1106 et seq. to examine, license and renew license for duly qualified applicants and may limit, deny, suspend or revoke a license or authorization to practice nursing, may issue a public or private censure and levy administrative fines consistent with K.S.A. 74-1110, if a violation of K.S.A. 65-1120(a) is established.

FACTS COMMON TO ALL COUNTS

- 5. The facts below are common to all counts:
- (a) In January 2009, while employed with Life Care Center of Kansas City, Kansas, respondent failed to notify a physician of a patient with blood sugar count of 29 and transferred the patient to dialysis. Lifecare Center of Kansas City's policy and procedure regarding blood glucose, requires staff to call a doctor if the blood sugar levels are less than 60 and over 400.

(b) Respondent failed to report a misdemeanor conviction on her most recent renewal application as required by K.A.R. 60-3-113. Respondent plead guilty to a charge of theft under \$500.00 on or about 7/18/2000 in the Municipal Court of Mission, Kansas. Respondent did not report the conviction on her renewal application filed on 6/29/2010.

VIOLATIONS

6. Respondent has violated the Kansas Nurse Practice Act as follows:

Count 1: K.S.A.65-1120(a)(1), to be guilty of fraud or deceit in practicing nursing or in procuring or attempting to procure a license to practice nursing.

Count 2: K.S.A.65-1120(a)(3), Professional Incompetency by K.S.A. 65-1120(e)(2), repeated instances involving failure to adhere to the applicable standard of care to a degree which constitutes ordinary negligence, as determined by the board.

Count 3: K.S.A. 65–1120(a)(6), unprofessional conduct by K.A.R. 60-3-110(c), failing to take appropriate action or to follow policies and procedures in the practice situation designed to safeguard each patient.

WHEREFORE, petitioner requests a finding that the respondent has violated the Nurse Practice Act, that respondent's license to practice nursing in Kansas be revoked, and that costs of this action be assessed to the respondent in the amount of \$70.00.
