**SUMMARY ORDER**

Now this 9<sup>th</sup> day of September, 2014, the above matter comes before the Kansas State Board of Nursing (Board) pursuant to authority granted to the Board by K.S.A. 65-1120. The Board hereby proposes to find facts and take disciplinary action against the renewal application and license of Maurita S. Francis, Licensed Practical Nurse (LPN), by way of Summary Order as provided by K.S.A. 77-537.

**FINDINGS OF FACT**

1. Applicant submitted a renewal application to practice as Licensed Practical Nurse (LPN) in the state of Kansas. The Board has jurisdiction over the renewing licensee and the subject matter of this action.
2. Applicant's address of record is 5416 Cleveland Ave., Kansas City, Missouri 64130.
3. Review of the licensee's renewal application and other information gathered by the Board revealed the following information upon which this action is based.
4. On or about 1/3/2013, the Board received licensee's renewal application to practice as an LPN in the state of Kansas. Licensee answered "no" to the question about whether or not she had obtained the 30 continuing education hours required for renewal by K.S.A. 65-1117(a) and K.A.R. 60-9-106(b).
5. Licensee is not a first time renewal expiring within 30 months following licensure examination or a renewal expiring within 9 months of reinstatement or endorsement, either of which would be an exception to the requirement for continuing education.
6. Licensee continued with the process and submitted the renewal application despite the written instructions telling the licensee that the process should not be completed if the 30 hours of continuing education was not obtained.
7. Licensee was given the opportunity to provide proof of completion of thirty (30) hours of continuing education for renewal. Licensee did not respond.
8. Licensee has not submitted proof of the required 30 hours of continuing education allegedly obtained between the dates of 4/1/2011 and 1/2/2013, the licensee's prior licensing period, in order to qualify for renewal of the LPN license.

### CONCLUSIONS OF LAW

1. Pursuant to K.S.A. 65-1117(a) and K.A.R. 60-9-106(b) each applicant for renewal of a Kansas LPN license shall submit proof of completion of 30 hours of CNE obtained within the prior licensing period.
2. Pursuant to K.S.A. 65-1120(a), the Kansas State Board of Nursing may deny, revoke, limit or suspend any license, certificate of qualification or authorization to practice as an LPN that is issued by the board or applied for under this act or may publicly or privately censure a licensee or holder of a certificate of qualification or authorization, if the applicant, licensee or holder of a certificate of qualification or authorization is found to have violated the Kansas Nurse Practice Act Statutes. The above fact findings establish evidence that the applicant violated the following provisions of the Act:
  - (a) K.S.A. 65-1120(a)(6), to be guilty of unprofessional conduct as defined by rules and regulations of the Board, K.A.R. 60-3-110(b) assuming duties and responsibilities within the practice of nursing without making or obtaining adequate preparation or maintaining competency.
  - (b) K.S.A. 65-1120(a)(7) wilfully violating any of the provisions of the Kansas Nurse Practice Act and K.S.A. 65-1117(a) and K.A.R. 60-9-106(b) every licensee with an active LPN license shall submit with the renewal application evidence of satisfactory completion of a program of continuing education as required by the Board which is 30 hours of continuing education obtained within the prior licensing period.
3. Licensee has violated the Kansas Nurse Practice Act by failing to complete thirty (30) hours of CNE and has failed to respond to the Board's request that she provide the Board with proof of completion. Licensee has not show that she was qualified for a license at the time she submitted her renewal to the Board on or about 1/3/2013. Board has given her the opportunity to provide the documentation of completion of 30 hours of CNE but the licensee has not responded to the Board. Licensee has failed to contact the Board.
4. K.S.A. 77-511(a)(2)(A) of the Kansas Administrative Procedure Act authorizes the use of summary proceedings by a state agency if the use of summary proceedings does not violate any provision of law and the protection of the public interest does not require the state agency to give notice and an opportunity to participate to persons other than the parties.
5. The role of the Kansas State Board of Nursing is to protect citizens of Kansas.

#### **IT IS THEREFORE ORDERED BY THE KANSAS STATE BOARD OF NURSING THAT**

1. **Licensee's renewal application to practice as an LPN in the state of Kansas is denied and her license is revoked.**
2. **Licensee shall not practice nursing in the state of Kansas.**

3. Licensee shall pay \$70.00 costs of this action to the Board within thirty (30) days of the effective day of this Order.

Pursuant to K.S.A. 77-537, this decision, which is called a Summary Order, is subject to your request for a hearing. If you desire a hearing, you must submit or direct a **written** request for hearing to: Kansas State Board of Nursing, Legal Division, 900 SW Jackson, Suite 1051, Topeka, Kansas 66612-1230, (785) 296-4325. **THIS REQUEST MUST BE SUBMITTED WITHIN FIFTEEN (15) DAYS FROM THE DATE OF THIS ORDER.** If a hearing is not requested in the time and manner stated, this Summary Order becomes effective as a final order, without further notice, upon the expiration of the time for requesting a hearing.

Pursuant to K.S.A. 77-531, if the Summary Order is served by mail, three days are added to the time limits set out above.


