PROPOSED DEFAULT ORDER TO SUSPEND LICENSE

NOW ON THIS 31st day of January, 2007, petitioner, the Kansas State Board of Nursing, appears by disciplinary counsel, Mark A. Knight, for a Hearing on the Petition. Respondent does not appear.

Wherefore, the Presiding Officer finds as follows:

1. Respondent is licensed to practice nursing in Kansas through 12/31/2008. The Kansas State Board of Nursing has jurisdiction over the licensee and the subject matter of this action.
2. Petitioner sent a copy of the petition and notice of this hearing to respondent's last known address and service is proper.
3. Petitioner moves for issuance of a proposed default order suspending respondent's license. The petitioner's request is granted by default.
4. The petition is hereby granted and incorporated into this order as if set forth herein. Respondent violated the Nurse Practice Act as alleged in the petition.
5. Per petitioner's request, respondent's license to practice nursing is suspended. Respondent may not practice nursing in Kansas. Respondent is to mail the license card to the Kansas State Board of Nursing office immediately.
6. Costs of the action of \$70 are assessed to respondent to be paid to the board by cash or money order within 30 days of the effective date of this order.
7. Respondent shall immediately forward his or her original Kansas Licensed Mental Health Technician license to the Kansas State Board of Nursing.
8. Suspension of Respondent's license is to be immediately lifted upon Respondent providing to the Kansas State Board of Nursing, Original Certificates verifying completion of two

(2) hours of Continuing Nurse Education on the Kansas Nurse Practice Act and three (3) hours of Continuing Nurse Education on Medication Administration.

9. Disciplinary counsel shall mail a copy of this proposed default order to respondent's last known address.
