**CONSENT AGREEMENT  
 FOR WARNING**

**INTRODUCTION**

This document is a Consent Agreement regarding Donna E. Locsin's license to practice practical nursing in the State of Maine. The parties enter into this Agreement pursuant to 10 M.R.S.A. § 8003(5)(A-1)(1), § 8003(5)(B) and 32 M.R.S.A. § 2105-A(1-A)(A). The parties to this Consent Agreement are Donna E. Locsin ("Licensee"), Maine State Board of Nursing ("Board") and the Office of the Attorney General, State of Maine. An informal conference was held on April 26, 2004. The parties reached this Agreement on the basis of information submitted by Pines Health Services by correspondence dated December 1, 2003.

**FACTS**

1. Donna E. Locsin has been a licensed practical nurse for 32 years, licensed to practice in Maine since 1978.
2. Donna E. Locsin admits that she called in a prescription for a patient to a pharmacy without authorization of the attending physician.
3. Donna E. Locsin denies that she administered a prescription drug to a patient without authorization of the attending physician.
4. There was no documented patient harm.

**AGREEMENT**

5. Donna E. Locsin agrees and understands that her conduct constitutes grounds for discipline under Title 32 M.R.S.A. § 2105-A(2)(F) and (2)(H) and Chapter 4 I.A.6., 4.3.A., 4.3.F. and 4.3.Q. of the Rules and Regulations of the Maine State Board of Nursing. Donna E. Locsin is hereby **WARNED** because she:
  - a. Performed acts beyond the authorized scope of the level of nursing for which she is licensed.
  - b. Failed to take appropriate action or to follow policies and procedures in the practice situation designed to safeguard the patient.

- c. Possessed, obtained, furnished or administered prescription drugs to a person, except as directed by a person authorized by law to prescribe drugs.
6. Donna E. Locsin understands that this Consent Agreement imposes discipline regarding her license to practice practical nursing in the State of Maine. Ms. Locsin understands that she does not have to execute this Consent Agreement and that she has the right to consult with an attorney before entering into this Consent Agreement.
7. Donna E. Locsin affirms that she executes this Consent Agreement of her own free will.
8. Modification of this Consent Agreement must be in writing and signed by all the parties.
9. This Consent Agreement is not subject to review or appeal by the Licensee, but may be enforced by an action in the Superior Court.
10. This Consent Agreement becomes effective upon the date of the last necessary signature below.




