INTRODUCTION

This document is a Consent Agreement regarding Mary M. Paquette's license to practice professional nursing in the State of Maine, entered into pursuant to 32 M.R.S.A. § 2105-A(1-A)(A) and 10 M.R.S.A. § 8003(5)(B). The parties to this Consent Agreement are Mary M. Paquette, R.N., the Maine State Board of Nursing ("the Board") and the Department of Attorney General, State of Maine. This Consent Agreement arose out of an informal conference held on February 11, 1998 regarding information submitted by CHANS through letters dated June 3 and July 8, 1997.

FACTS

1. On or about May 29, 1997, Mary M. Paquette rubbed a client's neck and shoulders while sitting on the client's lap.

AGREEMENT

1. Ms. Paquette agrees that her conduct in this matter constitutes grounds for discipline under 32 M.R.S.A. § 2105-A(2)(F) and agrees to accept a **WARNING**. The Board agrees to take no further disciplinary action upon these facts.
2. Ms. Paquette understands that this document is a Consent Agreement which constitutes disciplinary action and affects her license to practice nursing in Maine. This Consent Agreement may be amended only in writing, signed by all parties. Ms. Paquette understands that she does not have to execute this Consent Agreement and that she has the right to consult with an attorney before entering this Consent Agreement. Ms. Paquette affirms that she executes this Consent Agreement of her own free will.
