**INTRODUCTION**

This document is a Consent Agreement regarding Lorraine F. Stormann’s license to practice practical nursing in the State of Maine. The parties enter into this Agreement pursuant to 10 M.R.S.A. § 8003(5)(B) and 32 M.R.S.A. § 2105-A(1-A)(C). The parties to this Consent Agreement are Lorraine F. Stormann (“Licensee”), Maine State Board of Nursing (“Board”) and the Department of Attorney General, State of Maine. The parties reached this Agreement on the basis of information submitted by Westgate Manor by a letter dated October 5, 2000 and from information submitted by the State of Maine, Department of Human Services, Division of Licensing and Certification report no. 00BNF919 dated September 29, 2000.

**FACTS**

1. Lorraine F. Stormann’s employment with Westgate Manor was terminated for diverting drugs.
2. Lorraine F. Stormann admits that she diverted the drug Oxyfast from Westgate Manor.
3. Lorraine F. Stormann admits that she has an addiction problem and on that basis has voluntarily surrendered her practical nursing license.

**AGREEMENT**

4. Lorraine F. Stormann agrees and understands that her conduct constitutes grounds for discipline under 32 M.R.S.A. §2105-A(2)(B), § 2105-A(2)(F), § 2105-A(2)(H) and Chapter 4(3)(P) & (3)(Q) of the Nursing Board Rules.
5. The Maine State Board of Nursing will accept Lorraine F. Stormann’s voluntary surrender of her license.
6. Lorraine F. Stormann shall not work, in any capacity, in the health care field, including in a veterinarian’s office, while her nursing license is surrendered. In addition, Ms. Stormann is not to seek employment where the handling or dispensing of drugs is part of the job responsibility.
7. Lorraine F. Stormann may petition the Board for reinstatement of her license. Ms. Stormann agrees and understands that her license will not be reinstated until and unless the Board, upon Ms. Stormann’s written request, votes to reinstate Ms. Stormann’s license.

8. Lorraine F. Stormann understands that this document imposes discipline regarding her license to practice practical nursing in the State of Maine for violations under 32 M.R.S.A. § 2105-A(2)(E) and A(2)(F).
9. Lorraine F. Stormann understands that she does not have to execute this Consent Agreement and that she has the right to consult with an attorney before entering into this Consent Agreement.
10. Lorraine F. Stormann affirms that she executes this Consent Agreement of her own free will.
11. Modification of this Consent Agreement must be in writing and signed by all parties.
12. This Consent Agreement is not subject to review or appeal by the Licensee, but may be enforced by an action in the Superior Court.
13. This Consent Agreement becomes effective upon the date of the last necessary signature below.
