INTRODUCTION

This document is a consent agreement regarding Pamela Strickland's license to practice nursing in the State of Maine, entered into pursuant to 10 M.R.S.A. Section 8003(5)(B) and 5 M.R.S.A. Section 9053(2). The parties to this consent agreement are Pamela Strickland, the Maine State Board of Nursing ("the Board") and the Department of the Attorney General, State of Maine.

STATEMENT OF FACTS

- 1. Pamela Strickland's license to practice nursing in the State of Maine expired on July 10, 1994.
- 2. Pamela Strickland continued to practice nursing in the State of Maine after her license had expired.
- 3. An individual practicing nursing as a nurse during the time the individual's license has lapsed is considered an illegal practitioner and is subject to the penalties provided for violations of Title 32, Chapter 31. See 32 M.R.S.A. Section 2206.
- 4. The practice of nursing by Pamela Strickland after her license lapsed is in violation of Title 32, Chapter 31.
- 5. Pamela Strickland acknowledges that she has continued to practice nursing in the State of Maine without a valid license but is now requesting the Board to reinstate her license.
- 6. Pursuant to 32 M.R.S.A. Section 2105-A(2)(H), violations of Title 32, Chapter 31 are grounds for the Board to refuse to reissue a license.

AGREEMENT

The parties agree that Pamela Strickland's request for reinstatement of license shall be granted with the following conditions:

- A. Pamela Strickland shall pay a FINE in the amount of \$720.
- B. Pamela Strickland shall pay a reinstatment fee of \$10 in addition to the renewal fee of \$40.
- C. Pamela Strickland understands and agrees that if in the future she practices nursing without a valid license, the Board may consider the facts set forth herein to deny reinstatement and the State of Maine may pursue any and all penalties provided by law against Pamela Strickland for unlicensed practice.
