NOTICE OF INFORMAL CONFERENCE BEFORE AN AGENCY SUBORDINATE

Dear Ms. Bell:

This letter is official notification that an informal conference of the Virginia Board of Nursing will be held on **February 11, 2008, at 2:00 p.m.**, at the Department of Health Professions, Perimeter Center, 9960 Mayland Drive, Suite 201, Richmond, Virginia. In accordance with §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), this informal conference will be held before an agency subordinate of the Board of Nursing. This informal conference will be convened as a public meeting pursuant to § 2.2-3700 *et seq.* of the Code. The agency subordinate will inquire into allegations that you may have violated certain laws and regulations governing professional nursing practice in Virginia.

Specifically:

1. You may have violated § 54.1-3007(2), (5), and (6) of the Code and 18 VAC 90-20-300(A)(2)(c) in that during the course of your employment with Pediatric Associates of Charlottesville, Charlottesville, Virginia ("PAC"), by your own admission, you self-injected cocaine in the bathroom while at work on or about October 3, 2007, and November 2, 2007, using syringes and needles that you had taken from PAC supplies. On both occasions you were in the bathroom for extended periods of time, and left work immediately afterward. As you left work on or about November, 2, 2007, you were talking in a fast gibberish.

2. You may have violated § 54.1-3007(6) of the Code in that during the course of your employment with UVA HealthSouth, Charlottesville, Virginia ("HealthSouth"):

a. On or about May 26, 2006, you were not on your hall at the time that medications needed to be passed, and you were located in your car in the parking lot with a blood-stained ace bandage at your side and blood on your hands.

b. On or about April 14, 2006, you spent 2 ½ hours in the bathroom.

3. You may have violated § 54.1-3007(2), (5), and (8) of the Code and 18 VAC 90-20-300(A)(2)(e) and (f) of the Board of Nursing Regulations in that in or about the period September 10, 2007, through September 21, 2007, during the course of your employment with Interim Health Care, Staunton, Virginia ("Interim"), you failed to properly suction Client A, and failed to wash your hands before or after suctioning her. You also failed to clean Client A's peg tube site, or change her diaper as frequently as needed. By your own admission, you documented that you provided care to Client A that you did not, in fact, provide.

4. You may have violated § 54.1-3007(2) of the Code and 18 VAC 90-20-300(A)(2)(e) of the Board of Nursing Regulations in that on your applications for employment at Interim, dated February 2, 2007, and at PAC, dated June 16, 2007, you stated that your reason for leaving HealthSouth was "complications from pregnancy" when, in fact, your employment was terminated.

In its deliberations, the agency subordinate may use the Sanction Reference Points System, as contained in the Sanction Reference Manual. The manual, which is a guidance document of the Board, may be accessed at <http://www.dhp.virginia.gov/nursing>. Please click on *Guidance Documents*, then select #90-7. You may also request a paper copy from the Board office by calling (804) 367-4515.

After consideration of all information, the agency subordinate may:

- If the agency subordinate finds that there is insufficient evidence to warrant further action or that the charges are without foundation, notify you by mail that your record has been cleared of any charge which might affect your right to practice nursing in the Commonwealth;
- Recommend findings of fact, conclusions of law and a sanction, to include a reprimand, placing you on probation with terms, suspension or revocation of your license, or imposing a monetary penalty pursuant to § 54.1-2401 of the Code.

Further, the agency subordinate may refer this matter for a formal administrative proceeding pursuant to § 2.2-4020 of the Code.

Since the allegations listed above involve impairment, please be advised that you may make application to the Health Practitioners' Intervention Program ("HPIP"), which is available to all health care practitioners licensed in Virginia. A brochure about the HPIP is enclosed. Should you enter into a written agreement with the HPIP prior to your informal conference, the agency subordinate will take that into consideration when making a recommendation in your case.

Board's Review of Agency Subordinate's Recommended Decision

If you **appear in person or by counsel at the informal conference**, the recommendation of the agency subordinate will be presented to a quorum of the Board. The Board may accept or modify the recommendation, or reject the recommendation and move the case to formal hearing. If you do not agree with the decision of the Board, you have the right to a formal administrative hearing before the Board.

If you **fail to appear in person or by counsel at the informal conference**, the recommendation of the agency subordinate will be presented to a quorum of the Board. The Board may accept or modify the recommendation, or reject the recommendation. The Board's decision regarding the agency subordinate's recommendation is a final order that can only be appealed to circuit court as provided by Rule 2A:2 of the Supreme Court of Virginia.

You have the right to information that will be relied upon by the agency subordinate in making a decision. Therefore, I enclose a copy of the documents that will be distributed to the agency subordinate, and will be considered when discussing the allegations with you and when deliberating upon your case. **These documents are enclosed only with the original notice sent by certified mail, which you may be required to claim at the post office. Please bring these documents with you to the informal conference.**

To facilitate this proceeding, you should submit five copies of any documents you wish the Committee to consider to the Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 300, Richmond, VA 23233, by February 6, 2008. Your documents may not be submitted by facsimile or email.


You may be represented by an attorney at the informal conference. If you obtain counsel, you should do so as soon as possible, because absent good cause to support a request for a continuance, the informal conference will be held on February 11, 2008. A request to continue this proceeding must state **in detail** the reason for the request and must establish good cause. Such request must be made, in writing, to me at the address listed on this letter and must be received by 5:00 p.m. on February 6, 2008. Only one such motion will be considered. Absent critical circumstances, such as personal or family illness, a request for a continuance after February 6, 2008, will not be considered.
