CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Gail Delorise Cobb Moran, L.M.T., as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Moran's license to practice massage therapy in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Gail Delorise Cobb Moran, L.M.T., was issued License Number 0019-002545 to practice massage therapy on December 1, 2000, which is scheduled to expire on May 31, 2019.
- 2. Ms. Moran violated Virginia Code § 54.1-3007(2) and (5) and 18 VAC 90-50-90(2)(g) and (i) of the Regulations Governing the Certification of Massage Therapists ("Regulations"), incorporating Section VII of the Code of Ethics of the National Certification Board for Therapeutic Massage and Bodywork, in that during the course of her ownership of Breezy Hill Day Spa, Staunton, Virginia, beginning in May 2016, she employed two unlicensed individuals as massage therapists and allowed them to perform massages on clients. Neither of these individuals had been authorized by the Board to engage in the provisional practice of massage therapy after having applied for licensure pursuant to 18 VAC 90-50-60 of the Regulations.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. Gail Delorise Cobb Moran, L.M.T., is REPRIMANDED.
- 2. Ms. Moran shall comply with all laws and regulations governing the practice of massage therapy in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
