CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Zachary Fletcher Irby, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Mr. Irby's application for licensure by examination to practice professional nursing in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Zachary Fletcher Irby submitted an application for licensure by examination to practice professional nursing in the Commonwealth of Virginia on June 7, 2017.
2. Mr. Irby violated Virginia Code § 54.1-3007(1) and 18 VAC 90-19-230(A)(1)(b) of the Regulations Governing the Practice of Nursing in that he failed to disclose a 2007 conviction for giving a false report to the police, a misdemeanor, in the Montgomery/Blacksburg, Virginia, General District Court.
4. Mr. Irby otherwise meets the requirements of Virginia Code § 54.1-3017.

CONSENT

Zachary Fletcher Irby, by affixing his signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document;
2. I am fully aware that without my consent, no legal action can be taken against me except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 *et seq.*;

3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;

4. I waive my right to an informal conference;

5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;

6. I consent to the entry of the following Order affecting my application for licensure by examination to practice professional nursing in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

1. Zachary Fletcher Irby is REPRIMANDED.

2. The application of Zachary Fletcher Irby for licensure to practice professional nursing in the Commonwealth of Virginia is APPROVED.

3. Upon successful completion of the NCLEX-RN examination, Mr. Irby shall be issued an unrestricted license to practice professional nursing in the Commonwealth of Virginia.

4. Mr. Irby shall comply with all laws and regulations governing the practice of nursing in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.

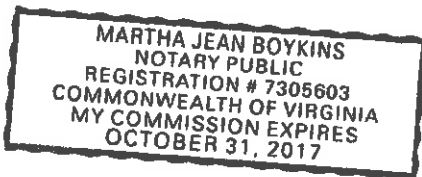
