### CONSENT ORDER

### JURISDICTION AND PROCEDURAL HISTORY

The Virginia Committee of the Joint Boards of Nursing and Medicine ("Committee of the Joint Boards") and Beckie Louise Turner, L.N.P., as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Turner's license to practice as a nurse practitioner in the Commonwealth of Virginia.

## FINDINGS OF FACT AND CONCLUSIONS OF LAW

- Beckie Louise Turner, L.N.P., was issued License Number 0017-139386 to practice as a 1. nurse practitioner on March 17, 2009, which is scheduled to expire on April 30, 2018. Ms. Turner was also issued Prescriptive Authority Number 0017-139386 on March 17, 2009, which is scheduled to expire on April 30, 2018.
- Ms. Turner violated Virginia Code § 54.1-3007(2) and 18 VAC 90-20-300(A)(2)(e) of 2. the Regulations Governing the Practice of Nursing (currently found at 18 VAC 90-19-230(A)(2)(e), effective February 24, 2017) and 18 VAC 90-30-220(4) of the Regulations Governing the Licensure of Nurse Practitioners in that in November 2016, she falsified her CPR certification card by altering the issue and recommended renewal dates.

### CONSENT

Beckie Louise Turner, L.N.P., by affixing her signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document and am represented by Nicholas Balland, Esq.;
- 2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Committee of the Joint Boards; and the right to representation by counsel;
  - I waive my right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Committee of the Joint Boards is a party;
- 6. I consent to the entry of the following Order affecting my right to practice as a nurse practitioner in the Commonwealth of Virginia.

#### ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Committee of the Joint Boards hereby ORDERS as follows:

- 1. Beckie Louise Turner, L.N.P., is REPRIMANDED.
- 2. Ms. Turner shall comply with all laws and regulations governing the practice of nurse practitioners in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
