CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Lauryn E. Hudgins, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Hudgins' application for licensure by examination to practice professional nursing in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Lauryn E. Hudgins submitted an application for license by examination to practice professional nursing in the Commonwealth of Virginia on April 14, 2017. Her primary state of residence is Virginia.
- 2. Ms. Hudgins violated Virginia Code § 54.1-3007(4) in that on September 4, 2014, in the General District Court of Albemarle County, Virginia, she was convicted of shoplifting/concealment, a misdemeanor crime of moral turpitude. She was sentenced to 30 days' incarceration, suspended, on the condition that she be of good behavior for two years, and ordered to pay court costs.
- 3. Ms. Hudgins submitted evidence that she has paid the court costs associated with this conviction.
 - 4. Ms. Hudgins otherwise meets the requirements of Virginia Code § 54.1-3017.

CONSENT

- 2. I am fully aware that without my consent, no legal action can be taken against me except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;
 - I waive my right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my application for licensure to practice professional nursing in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. The application of Lauryn E. Hudgins for licensure to practice professional nursing in the Commonwealth of Virginia is APPROVED. Upon successful completion of the NCLEX-RN examination, Ms. Hudgins shall be issued an unrestricted license.
 - 2. Lauryn E. Hudgins is REPRIMANDED.
- 3. Ms. Hudgins shall comply with all laws and regulations governing the practice of professional nursing in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
