**CONSENT ORDER**

The Virginia Board of Nursing ("Board") and Jasmine Myers, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Myers' application for certification by examination to practice as a nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

**FINDINGS OF FACT**

1. Jasmine Myers submitted an application for certification by examination to practice as a nurse aide in Virginia, which was received by the Board on April 2, 2010.
2. Ms. Myers has been convicted of the following criminal offenses:
  - a. On October 3, 2007, in the General District Court of the City of Roanoke, Ms. Myers was convicted of petit larceny. She was sentenced to 90 days incarceration, with 82 days suspended.
  - b. On May 6, 2009, in the Circuit Court of the City of Roanoke, Virginia, Ms. Myers was convicted of Grand Larceny. She was sentenced on July 2, 2009, to 2 years incarceration, with all but 20 days suspended on certain terms and conditions, including community service and one year supervised probation.

**CONCLUSIONS OF LAW**

1. Finding of Fact No. 2 constitutes a violation of § 54.2-3007(4) of the Code of Virginia (1950), as amended ("Code").
2. Ms. Myers otherwise meets the requirements of § 54.1-3023 of the Code.

**CONSENT**

Jasmine Myers, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact contained herein and waives her right to contest such Findings of Fact in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her application to practice as a nurse aide in Virginia.

**ORDER**

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. The application of Jasmine Myers for certification by examination as a nurse aide is APPROVED. Upon successful completion of the NNAAP examination, Ms. Myers shall be issued an unrestricted certificate to practice as a nurse aide in the Commonwealth.
2. Ms. Myers is hereby REPRIMANDED.
3. Ms. Myers shall maintain a course of conduct in her capacity as a nurse aide commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
