received this decision or the date it was mailed to her, whichever occurred first) within which to appeal this

REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Jane Elliott, R.N., Ph.D., serving as

Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal conference on June

15, 2017 in Henrico County, Virginia, to inquire into evidence that Tricia R. Perry, R.N., may have

violated certain laws and regulations governing the practice of professional nursing in the

Commonwealth of Virginia.

Ms. Perry did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated May 19, 2017, the Board sent a Notice of Informal Conference ("Notice") to

Ms. Perry notifying her that an informal conference would be held on June 15, 2017. The Notice was

sent by certified and first class mail to the legal address of record on file with the Board. The Notice

sent by certified mail was returned to the Board office unclaimed and was marked "return to sender, no

mail receptacle, unable to forward." The Notice sent by first class mail was not returned to the Board

office. Accordingly, the Agency Subordinate concluded that adequate notice was provided to Ms.

Perry and the informal conference proceeded in her absence.

Recommended Findings of Fact and Conclusions of Law

- 1. Tricia R. Perry, R.N., was issued License Number 0001-187594 to practice professional nursing on October 2, 2003, which expired on January 31, 2017. At all times relevant to the findings herein, said license was in full force and effect. Her primary state of residence is Virginia.
- 2. Ms. Perry violated Virginia Code § 54.1-3007(6) in that she is unsafe to practice professional nursing due to mental illness, as evidenced by the following:
- a. Between November 30, 2016 and December 6, 2016, she received inpatient psychiatric treatment at Tucker Pavilion, CJW Medical Center, Richmond, Virginia ("Tucker Pavilion"). Her discharge diagnoses included major depressive disorder, recurrent, severe without psychotic features and anxiety disorder.
- b. Between January 20, 2016 and January 26, 2016, she received inpatient psychiatric treatment at Tucker Pavilion for recurrent major depression.
- c. Between July 31, 2015 and August 6, 2015, she received inpatient psychiatric treatment at Tucker Pavilion. Her discharge diagnoses included major depressive disorder, recurrent with psychotic features and generalized anxiety disorder.
- 3. Ms. Perry failed to respond to the Department of Health Professions investigator's contact attempts following the investigation of her most recent admission.
- 4. Ms. Perry has a history of noncompliance with her medications, which led to increased suicidal ideations, and she has a history of failure to follow through with aftercare from her previous psychiatric admissions.
- 5. As of April 2016, Ms. Perry was unemployed. Her employment with CJW Medical Center was terminated following her January 2016 psychiatric admission. She resigned from her

previous employment with Envoy of Lawrenceville, Lawrenceville, Virginia, following her July 2015

psychiatric admssion.

6. Pursuant to Virginia Code § 54.1-2400.2(K), the Board considered whether to disclose

or not disclose Ms. Perry's health records or health services.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate

recommends that the Board issue an Order as follows:

1. The right of Tricia R. Perry, R.N., to renew her license to practice professional nursing in

the Commonwealth of Virginia is INDEFINITELY SUSPENDED.

2. The license of Tricia R. Perry, R.N., will be recorded as SUSPENDED.

3. This suspension applies to any multistate privilege to practice professional nursing.

4. Should Ms. Perry seek reinstatement of her license, an administrative proceeding shall

be convened to consider such application. At such time, the burden shall be on Ms. Perry to

demonstrate that she is safe and competent to return to the practice of professional nursing. Ms. Perry

shall be responsible for any fees that may be required for the reinstatement and/or renewal of the

license prior to issuance of the license to resume practice.
