**CONSENT ORDER**

**JURISDICTION AND PROCEDURAL HISTORY**

The Virginia Board of Nursing ("Board") and Lindsey Ann Burke, L.P.N., as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Burke's license to practice practical nursing in the Commonwealth of Virginia.

**FINDINGS OF FACT AND CONCLUSIONS OF LAW**

1. Lindsey Ann Burke, L.P.N., was issued License Number 0002-085958 to practice practical nursing on October 21, 2011, which is scheduled to expire on September 30, 2017. Her primary state of residence is Virginia.
2. Ms. Burke violated Virginia Code § 54.1-3007(2) and 18 VAC 90-20-300(A)(2)(e) of the Regulations Governing the Practice of Nursing (currently found at 18 VAC 90-19-230(A)(2)(e), effective February 24, 2017) in that during the course of her employment with Senior Healthcare, Richmond, Virginia, on July 25, 27, and 31, 2016, Ms. Burke forged signatures on her timesheets for her assignment at Envoy of Staunton when she did not actually work there on those days.
3. Senior Healthcare terminated Ms. Burke's employment.

**CONSENT**

Lindsey Ann Burke, L.P.N., by affixing her signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document;

2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 *et seq.*;
3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;
4. I waive my right to an informal conference;
5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
6. I consent to the entry of the following Order affecting my licensure to practice practical nursing in the Commonwealth of Virginia.

### ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

1. Lindsey Ann Burke, L.P.N., is assessed a MONETARY PENALTY of \$500.00. This penalty shall be paid to the Board by certified check or money order made payable to the Treasurer of Virginia within 90 days from the date of entry of this Order. Failure to pay the full monetary penalty by the due date may cause the matter to be sent for collection and constitutes grounds for an administrative proceeding and further discipline.
2. Lindsey Ann Burke, L.P.N., shall comply with all laws and regulations governing the practice of nursing in the Commonwealth of Virginia.
3. Any violation of the foregoing terms and conditions of this Order or any statute or regulation governing the practice of nursing shall constitute grounds for further disciplinary action.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.

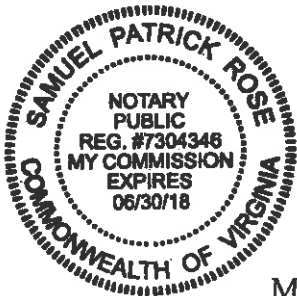
