CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Jalissa Danielle Washington, L.P.N., as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Washington's license to practice practical nursing in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Jalissa Danielle Washington, L.P.N., was issued License Number 0002-080358 to practice practical nursing on May 26, 2009, which is scheduled to expire on May 31, 2019. Her primary state of residence is Virginia.
- 2. During the course of her employment with American Critical Care Services ("ACCS"), Richmond, Virginia, in June and July of 2016, Ms. Washington was assigned to provide home health care to Patient A, a disabled child with a severe seizure disorder requiring constant visual monitoring.
- 3. Ms. Washington violated Virginia Code § 54.1-3007(2), (5), and (8) and 18 VAC 90-20-300(A)(2)(f) of the Regulations Governing the Practice of Nursing ("Regulations") (currently found at 18 VAC 90-19-230(A)(2)(f), effective February 24, 2017) in that:
 - a. She left Patient A unattended on several occasions to take smoke breaks.
- b. She failed to take and record Patient A's blood pressure as required by her care plan.
 - 4. Ms. Washington violated Virginia Code § 54.1-3007(2) and 18 VAC 90-20-

300(A)(2)(e) of the Regulations (currently found at 18 VAC 90-19-230(A)(2)(e), effective February 24, 2017) in that she documented vital signs for Patient A that she did not take.

5. ACCS terminated Ms. Washington's employment.

CONSENT

Jalissa Danielle Washington, L.P.N., by affixing her signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;
 - 4. I waive my right to an informal conference;
- 5. I neither admit nor deny the Findings of Fact and Conclusions of Law contained herein but waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my licensure to practice practical nursing in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. Jalissa Danielle Washington, L.P.N., is REPRIMANDED.
- 2. Jalissa Danielle Washington, L.P.N., shall comply with all laws and regulations governing the practice of nursing in the Commonwealth of Virginia.

3. Any violation of any statute or regulation governing the practice of nursing shall constitute grounds for further disciplinary action.
