CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Beatrice Valcourt, L.P.N., as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Valcourt's application for licensure by endorsement to practice practical nursing in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- Beatrice Valcourt submitted an application for licensure by endorsement to practice practical nursing in the Commonwealth of Virginia on April 6, 2016. Ms. Valcourt holds Florida License No. 5210248 to practice professional nursing. Her primary state of residence is Florida.
- 2. Ms. Valcourt violated Virginia Code § 54.1-3007(1) and 18 VAC 90-20-300(A)(1)(b) (currently found at 18 VAC 90-19-230(A)(1)(b) effective February 24, 2017) in that on her application for licensure to practice practical nursing, she answered "NO" to the question "Have you ever been convicted, pled guilty to or pled Nolo Contendere to the violation of any federal, state or other statute or ordinance constituting a felony or misdemeanor?" when, in fact, she pled guilty to, and was convicted of, obstruction of a highway due to intoxication.
 - 3. Ms. Valcourt otherwise meets the requirements of Virginia Code § 54.1-3021.

CONSENT

Beatrice Valcourt, L.P.N., by affixing her signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;
 - I waive my right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my application for licensure to practice practical nursing in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. Beatrice Valcourt is REPRIMANDED.
- 2. The application of Ms. Valcourt for licensure to practice practical nursing in the Commonwealth of Virginia is APPROVED. Ms. Valcourt shall be issued an unrestricted license to practice practical nursing in the Commonwealth of Virginia.
- 3. Ms. Valcourt shall comply with all laws and regulations governing the practice of nursing in the Commonwealth of Virginia.
