ORDER

JURISDICTION AND PROCEDURAL HISTORY

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), a Special Conference Committee of the Virginia Board of Nursing ("Board") held an informal conference on June 20, 2017, in Henrico County, Virginia, to receive and act upon Ms. Coley-Davis' application for reinstatement of her license to practice practical nursing in the Commonwealth of Virginia.

Ms. Davis appeared at this proceeding and was not represented by legal counsel.

NOTICE

By letter dated May 26, 2017, the Board sent a Notice of Informal Conference ("Notice") to Ms. Davis notifying her that an informal conference would be held on June 20, 2017. The Notice was sent by certified and first class mail to the legal address of record on file with the Board.

Upon consideration of the evidence, the Committee adopts the following Findings of Fact and Conclusions of Law and issues the Order contained herein.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Jasmine Renee Coley Davis, L.P.N., was issued License Number 0002-091429 to practice practical nursing on September 15, 2014, which was suspended on May 25, 2016. Her primary state of residence is Virginia.
- 2. By Order entered May 25, 2016, the Board indefinitely suspended Ms. Davis' license to practice practical nursing. This action was the result of Ms. Davis' poor nursing practices.

- 3. On February 10, 2017, Ms. Davis submitted an application for reinstatement of her license to practice practical nursing.
- 4. Ms. Davis submitted certificates of completion of 23 hours of continuing education. She also submitted a letter of recommendation from her pastor.
 - 5. Ms. Davis stated to the Committee that she plans to enter a RN program.
- 6. Ms. Davis stated to the Committee that she has learned that if she becomes overwhelmed while on duty, she will utilize appropriate resources such as her co-workers or her supervisor.
- 7. Ms. Davis has demonstrated that she is able to resume the safe and competent practice practical of nursing.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. The application of Jasmine Renee Coley Davis, L.P.N., for reinstatement of her license to practice practical nursing is APPROVED without restriction.
- 2. Ms. Davis shall comply with all laws and regulations governing the practice of nursing in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
