#### CONSENT ORDER

## JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Jamie E. Hunley, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Hunley's application for certification to practice as a nurse aide in the Commonwealth of Virginia.

## FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Jamie E. Hunley submitted an application for certificate by examination to practice as a nurse aide in the Commonwealth of Virginia on May 9, 2017.
- 2. Ms. Hunley violated Virginia Code § 54.1-3007(4) in that on May 1, 2014, in the General District Court of Gloucester County, Virginia, she was convicted of shoplifting, a misdemeanor crime of moral turpitude. She was sentenced to six months incarceration, with five months twenty days suspended, placed on probation for three years, ordered to undergo a substance abuse/mental health evaluation and follow any treatment recommendations, and ordered to pay fines and costs.
  - 3. Ms. Hunley otherwise meets the requirements of Virginia Code § 54.1-3023.

#### CONSENT

Jamie E. Hunley, by affixing her signature to this Consent Order, agrees to the following:

- I have been advised to seek advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;

- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel:
  - 4. I waive my right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my application for certification to practice as a nurse aide in the Commonwealth of Virginia.

#### **ORDER**

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. The application of Jamie E. Hunley for certification to practice as a nurse aide in the Commonwealth of Virginia is APPROVED. Upon successful completion of the NNAAP examination, Ms. Hunley shall be issued an unrestricted certificate.
  - 2. Jamie E. Hunley is REPRIMANDED.
- 3. Jamie E. Hunley shall comply with all laws and regulations governing the practice of certified nurse aides in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
