CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing (“Board”) and Emily Dawn Harris, C.N.A., as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Harris’s application for reinstatement of her certification to practice as a nurse aide in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Emily Dawn Harris, C.N.A., was issued Certificate Number 1401-119922 to practice as a nurse aide on July 7, 2007, which expired on July 31, 2014.
2. Ms. Harris submitted an application for reinstatement of her certificate to practice as a nurse aide in the Commonwealth of Virginia on February Day, 2017.
3. Ms. Harris violated Virginia Code § 54.1-3007(4) in that on November 24, 2015, she was convicted of shoplifting in the Patrick County, Virginia, General District Court.
4. Ms. Harris provided evidence that she has paid all court costs related to her conviction.
5. Ms. Harris otherwise meets the requirements for reinstatement of her certificate to practice as a nurse aide.

CONSENT

Emily Dawn Harris C.N.A., by affixing her signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document;
2. I am fully aware that without my consent, no legal action can be taken against me except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 *et seq.*;
3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;
4. I waive my right to an informal conference;
5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
6. I consent to the entry of the following Order affecting my application for reinstatement for certification to practice as a nurse aide in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

1. Emily Dawn Harris C.N.A., is REPRIMANDED.
2. The application of Ms. Harris for reinstatement of her certificate to practice as a nurse aide is APPROVED contingent upon upon successful completion of the NNAAP examination. Upon reinstatement, Ms. Harris shall be issued an unrestricted certificate to practice as a nurse aide in the Commonwealth of Virginia.

3. Ms. Harris shall comply with all laws and regulations governing the practice of certified nurse aides in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
