FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Stephanie Andrea Droguett, C.N.A., was issued Certificate Number 1401-105904 to practice as a nurse aide on September 30, 2004, which expired on September 30, 2015, was renewed on June 9, 2016, and now is scheduled to expire on September 30, 2017.
- 2. Ms. Droguett violated Virginia Code § 54.1-3007(5) in that during the course of her employment with Heartland Hospice, Warrenton, Virginia, between October 1, 2015 and May 24, 2016, Ms. Droguett practiced as a certified nurse aide after her certificate had expired.
 - 4. Ms. Droguett's employment was suspended for two weeks as a result of this incident.

This penalty shall be paid to the Board by certified check or money order made payable to the Treasurer of Virginia within 90 days from the date of entry of this Order. Failure to pay the full monetary penalty by the due date may cause the matter to be sent for collection and constitutes grounds for an administrative proceeding and further discipline.
- 2. Stephanie Andrea Droguett, C.N.A., shall comply with all laws and regulations governing the practice of certified nurse aides in the Commonwealth of Virginia.
