CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Selina Marie Jimenez Ballard, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Ballard's application for reinstatement of her license to practice practical nursing in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Selina Marie Jimenez Ballard was issued License Number 0002-079378 to practice practical nursing on October 31, 2008, which expired on August 31, 2012. Her primary state of residence is Virginia.
2. Ms. Ballard submitted an application for reinstatement of her license to practice practical nursing on January 25, 2017, wherein she disclosed criminal convictions that occurred in 2000 and 2003.
3. Ms. Ballard violated Virginia Code Section 54.1-3007(1) and 18 VAC 90-20-300(A)(1)(b) of the Regulations Governing the Practice of Nursing (currently found at 18 VAC 90-19-230(A)(1)(b) effective February 24, 2017) in that on the application for licensure by endorsement submitted to the Board on October 28, 2008, Ms. Ballard falsely indicated that she did not have any criminal convictions, when, in fact, she had two convictions as indicated below.
4. Ms. Ballard violated Virginia Code Section 54.1-3007(4) in that:

a. On December 1, 2000, in the Superior Court of Monmouth County, New Jersey, Ms. Ballard was convicted of theft by deception, a felony. She was sentenced to three years probation, and ordered to pay \$4,421.00 in restitution and \$600.00 in court fines.

b. On May 2, 2003, in the Superior Court of Monmouth County, New Jersey, Ms. Ballard was convicted of theft by deception, a felony. She was sentenced to three years incarceration and ordered to pay \$3,912.00 in restitution.

CONSENT

Selina Marie Jimenez Ballard, by affixing her signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document;
2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 *et seq.*;
3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;
4. I waive my right to an informal conference;
5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
6. I consent to the entry of the following Order affecting my application for reinstatement of my license to practice practical nursing in the Commonwealth of Virginia.


ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

1. Selina Marie Jimenez Ballard is REPRIMANDED.
2. The application of Selina Marie Jimenez Ballard for reinstatement of her license to practice practical nursing is APPROVED without restriction.
3. Selina Marie Jimenez Ballard shall comply with all laws and regulations governing the practice of practical nursing in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
