IN RE: ROBIN BORSOS, R.N. REINSTATEMENT APPLICANT

CONSENT ORDER

The Virginia Board of Nursing ("Board") and Robin Borsos, R.N., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Borsos' application for reinstatement of her license to practice professional nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Robin Borsos, R.N., was issued License No. 0001-094778 to practice professional nursing by the Virginia Board of Nursing on October 8, 1984. Said license expired on April 30, 1985. Ms. Borsos was issued License No. R087763 to practice professional nursing by the Maryland Board of Nursing on January 25, 1985. Said license is a single state licence and is set to expire on April 28, 2011. Ms. Borsos' primary state of residence is West Virginia.
2. Ms. Borsos submitted an application for reinstatement of her license which was received by the Board on January 3, 2011.
3. From August 21, 2010, until October 9, 2010, during the course of her employment as adjunct faculty with Mountain State University, Martinsburg, West Virginia, by her own admission, Ms. Borsos taught and supervised student nurses in a clinical setting at Winchester Medical Center, Winchester, Virginia, without a valid Virginia license.
4. Ms. Borsos stated that she thought her Maryland license allowed her to practice professional nursing in Virginia, as a multi-state privilege. Ms. Borsos stated that she was not aware that her Maryland license was a single state license due to her primary state of residence being West Virginia, a non-compact state.

CONCLUSIONS OF LAW

1. Finding of Fact No. 3 constitutes a violation of § of §§ 54.1-3007(3), 54.1-3008(A)(2) and (4) and 54.1-3011(C) of the Code of Virginia (1950) as amended, (“Code”).

CONSENT

Robin Borsos, R.N., by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her application for reinstatement of her license to practice professional nursing in Virginia.

ORDER


WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. The application of Robin Borsos, R.N., for reinstatement of her license to practice professional nursing in Virginia is APPROVED.
2. Prior to the issuance of her license, Ms. Borsos shall pay a MONETARY PENALTY of \$200.00.

3. Ms. Borsos shall maintain a course of conduct in her capacity as a professional nurse commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.

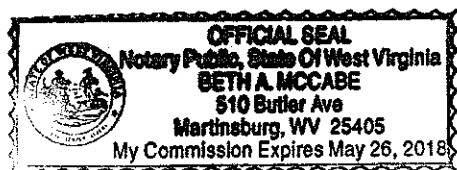
