NOTICE OF HEARING

Pursuant to §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended (“Code”), Kim H. G. Wynn, R.N., who, prior to its mandatory suspension by the Department of Health Professions on July 27, 2011, held License No. 0001-141448 to practice professional nursing in Virginia, is hereby given notice that a formal administrative hearing will be held in the presence of a panel of the Board of Nursing. The hearing will be held on November 16, 2011, at 10:00 a.m., at the offices of the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233, at which time Ms. Wynn will be afforded the opportunity to be heard in person or by counsel.

At the hearing, Ms. Wynn has the following rights, among others: the right to representation by counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Wynn desires any witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the Instructions for Requesting Subpoenas.

The purpose of the hearing is to receive and act upon Ms. Wynn’s application for reinstatement of her license to practice professional nursing in Virginia and to inquire into evidence that Ms. Wynn may have violated certain laws governing nursing practice in Virginia, as more fully set forth in the Statement of Particulars below.


The burden rests upon Ms. Wynn, as the applicant, to demonstrate that she is capable of resuming the safe and competent practice of professional nursing in Virginia.

Pursuant to § 54.1-2409 of the Code, reinstatement of Ms. Wynn's license requires the affirmative vote of three-fourths of the members of the Board in attendance at the hearing.

STATEMENT OF PARTICULARS

The Board alleges that Kim H. G. Wynn, R.N., may have violated § 54.1-3007(5), (7) and (8) of the Code in that on or about July 12, 2011, Ms. Wynn voluntarily surrendered her license to practice professional nursing in the State of Arizona in lieu of proceeding to a formal hearing. Specifically, by signing the Consent for Entry of Voluntary Surrender, Ms. Wynn admitted that on or about June 29, 2008, while employed with Mercy Gilbert Medical Center, Gilbert Arizona, she failed to reassess a patient after administering morphine, failed to record the patient's critically low blood pressure and low oxygen level, and failed to note the changes in the patient's vital signs and report the changes to the patient's physician and oncoming nurse.
