REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Jane Elliott, R.N., Ph.D., serving as

Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal conference on

February 16, 2017 in Henrico County, Virginia, to inquire into evidence that Jennifer Gray Vukmer,

R.N., may have violated certain laws and regulations governing the practice of professional nursing in

the Commonwealth of Virginia.

Ms. Vukmer appeared at this proceeding and was represented by Christopher Malone, Esquire.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated January 23, 2017, the Board sent a Notice of Informal Conference ("Notice") to

Ms. Vukmer notifying her that an informal conference would be held on February 16, 2017. The

Notice was sent by certified and first class mail to the legal address of record on file with the Board.

Recommended Findings of Fact and Conclusions of Law

Jennifer Gray Vukmer, R.N., was issued License Number 0001-162832 to practice 1.

professional nursing on February 17, 1999, which is scheduled to expire on December 31, 2017. At

all times relevant to the findings herein, said license was in full force and effect. Her primary state of

residence is Virginia.

- 2. Jennifer Gray Vukmer, R.N., violated Virginia Code § 54.1-3007(5) and (6) in that during the course of her employment with Westminster Canterbury, Richmond, Virginia, during her night shift from September 29, 2015 to September 30, 2015 ("September 29/30 2015 night shift"):
- a. Staff observed that Ms. Vukmer's speech was slow and slurred, she was confused, fidgety, had slow body movements, was not making sense, and was sweating.
- b. At the informal conference, Ms. Vukmer acknowledged that she was not safe to practice and was impaired during her shift. She said that prior to her shift she had worn two scopolamine patches at the same time, contrary to how it was prescribed by her treating neurologist in North Carlonia, to try and treat the symptoms of vertigo. She had also taken a dose each of oxycodone (C-II) and MS Contin (morphine, C-II) earlier in the day which had been prescribed to her for a migraine headache.
- c. Ms. Vukmer made several narcotic medication errors, including failing to sign out and administer scheduled medications, and signing out more than was scheduled to be given. Eighteen sign out logs accounting for ten patients contained numerous mark-outs, errors, and count discrepancies. There was no documentation to support the administration of any ordered medications during her shift or that any PRN medications removed were charted. One of Ms. Vukmer's patients reported that she did not recall receiving her pain medication during the September 29/30, 2015 night shift.
- 3. During the informal conference, Ms. Vukmer said she had previously seen a pain management physician, but it did not help. She continues to take oxycodone and MS Contin two to three times per week for migraines. She said her primary care physician is trying to decrease the amount prescribed.

- 4. Ms. Vukmer described the events of the September 29/30 2015 night shift as an "eye opening" experience. She reiterated that she was unsafe to practice during her shift. She repeated that she had worn two scopolamine patches during her shift and that the prescription only called for one. Ms. Vukmer explained that she took the scopolamine patches because she suffers from extreme vertigo and migraine headaches with vomiting.
- 5. Ms. Vukmer said she is currently taking the following medications: Reglan, scopolamine, MS. Contin, oxycodone, and Nuvigil. Ms. Vukmer explained that she had no prior side effects to the medications she takes.
- 6. Ms. Vukmer's employment with Westminster Canterbury was terminated on October 3, 2015, after she did not provide a urine sample following the September 29/30 night shift. She said that she is currently unemployed, but believes she is safe to practice.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate recommends that the Board issue an Order as follows:

- 1. Jennifer Gray Vukmer, R.N., is REPRIMANDED.
- 2. Jennifer Gray Vukmer, R.N., shall have an evaluation by a chemical dependency specialist satisfactory to the Board and shall have a written report of the evaluation, including a diagnosis, a recommended course of therapy, and a prognosis sent to the Board within 120 days from the date this Order is entered.
- 3. Jennifer Gray Vukmer, R.N., shall have a physical evaluation by a neurologist satisfactory to the Board and shall have a written report of the evaluation, including a diagnosis, a recommended course of therapy, and a prognosis sent to the Board within 120 days from the date this Order is entered.

4. Ms. Vukmer shall provide proof to the Board that she has provided the specialists with a

complete copy of this Order. Ms. Vukmer shall execute all releases necessary for unrestricted

communication between the specialists, and the Board and shall bear all costs associated with the

evaluations. Upon receipt of the required reports, the Board shall conduct a review of this matter and

may either schedule an additional administrative proceeding to consider the evaluations and make a

final disposition of the matter or close the matter without a further proceeding.

5. Jennifer Gray Vukmer, R.N., shall sign all required medical releases and authorization

forms within 120 days of the date of entry of this Order allowing for unrestricted communication

between and among the Board and her current and future treating healthcare providers.

6. Jennifer Gray Vukmer, R.N., shall not practice professional nursing until the Board has

considered and acted upon the results of the evaluation ordered in Terms 2 and 3.

7. Any violation of the foregoing terms and conditions of this Order or any statute or

regulation governing the practice of professional nursing shall constitute grounds for further

disciplinary action.
