REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Jane Elliott, R.N., Ph.D., serving as

Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal conference on

February 16, 2017 in Henrico County, Virginia, to inquire into evidence that Lisa Michelle Turner,

R.N., may have violated certain laws and regulations governing the practice of professional nursing in

the Commonwealth of Virginia.

Ms. Turner did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated January 23, 2017, the Board sent a Notice of Informal Conference ("Notice") to

Ms. Turner notifying her that an informal conference would be held on February 16, 2017. The Notice

was sent by certified and first class mail to the legal address of record on file with the Board.

certified mail receipt for the Notice sent by certified mail was signed and returned to the Board. The

Notice sent by first class mail was not returned to the Board office. Accordingly, the Agency

Subordinate concluded that adequate notice was provided to Ms. Turner and the informal conference

proceeded in her absence.

## Recommended Findings of Fact and Conclusions of Law

- 1. Lisa Michelle Turner, R.N., was issued License Number 0001-185247 to practice professional nursing on June 10, 2003, which expired on April 6, 2016. Her primary state of residence is Virginia.
- 2. By Order of the Board entered December 15, 2015 ("Board's Order"), the Board took no action on Ms. Turner's professional nursing license contingent upon her entry into the Health Practitioners' Monitoring Program ("HPMP") within 60 days of the entry of the Order, and her continued compliance with the HPMP. This Order was based on findings that Ms. Turner had been diagnosed with depression with psychotic features and ongoing mental health issue requiring treatment.
- 3. Ms. Turner violated Term Number 1 of the Board's Order, which required her to enroll into the Health Practitioners' Monitoring Program within 60 days of the entry of the Order, in that, to date, she has not enrolled.
- 4. In her interview with the investigator for the Department of Health Professions, Ms. Turner explained that, at the time of the October 2015 informal conference, she was living in North Carolina. Following the informal conference, she contacted staff with the Department of Health Professions, who advised her to inquire with the North Carolina Board of Nursing about entering a program similar to the HPMP. Ms. Turner said there was no equivalent program in North Carolina for mental health monitoring. Ms. Turner said that staff with the Department of Health Professions then advised her that she could also pursue licensure with the North Carolina Board of Nursing.
- 5. Ms. Turner indicated that she is living in North Carolina and her last nursing employment was in 2014.

6. On May 12, 2016, Ms. Turner's petition for licensure as a registered nurse by

endorsement in North Carolina was denied by the North Carolina Board of Nursing. However, Ms.

Turner was ordered to obtain a fitness for duty evaluation and reappear before the Licensure Review

Panel.

7. Pursuant to Virginia Code § 54.1-2400.2(K), the Board considered whether to disclose

or not disclose Ms. Turner's health records or health services.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate

recommends that the Board issue an Order as follows:

1. Lisa Michelle Turner, R.N., is REPRIMANDED.

2. The right of Lisa Michelle Turner, R.N., to renew her license to practice professional

nursing in the Commonwealth of Virginia is INDEFINITELY SUSPENDED.

3. The license of Lisa Michelle Turner, R.N., will be recorded as SUSPENDED.

4. This suspension applies to any multistate privilege to practice professional nursing.

5. Should Lisa Michelle Turner, R.N., seek reinstatement of her license, an administrative

proceeding shall be convened to consider such application. At such time, the burden shall be on Ms.

Turner to demonstrate that she is safe and competent to return to the practice of professional nursing.

Ms. Turner shall be responsible for any fees that may be required for the reinstatement and/or renewal

of the license prior to issuance of the license to resume practice.
