CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Sheri Randolph Bradshaw, R.N., as evidenced by

their signatures hereto, in lieu of proceeding to a formal administrative proceeding, enter into the

following Consent Order affecting Ms. Bradshaw's license to practice professional nursing in the

Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Sheri Randolph Bradshaw, R.N., was issued License Number 0001-179588 to practice

professional nursing on July 9, 2002, which is scheduled to expire on November 30, 2017. She also

holds licenses to practice professional nursing in the States of Alabama, California, Florida, Illinois,

Ohio, and Washington and in the Commonwealths of Massachusetts and Pennsylvania, all of which are

suspended. Her primary state of residence is Virginia.

2. By Consent Order entered March 25, 2015, the Board suspended Ms. Bradshaw's

license to practice professional nursing. By Order entered August 31, 2016, the Board granted Ms.

Bradshaw's application for reinstatement of her license contingent on her entry into and compliance

with the Virginia Health Practitioners' Monitoring Program ("HPMP")

3. Between July 23, 2015 and August 24, 2016, Ms. Bradshaw's license to practice

professional nursing in Washington, California, Florida, Illinois, Massachusetts, Pennsylvania, and

Ohio were suspended based on the Virginia Board of Nursing's Consent Order of March 25, 2015 suspending Ms. Bradshaw's Virginia license and subsequent actions in other states.

- 4. By Order entered November 15, 2016, pursuant to Virginia Code § 54.1-2409, the Virginia Department of Health Professions suspended Ms. Bradshaw's license based on the actions in California, Florida, Illinois, Ohio, Massachusetts, Pennsylvania, and Washington.
- 5. By Consent Order entered November 15, 2016, the Board reinstated Ms. Bradshaw's license to practice professional nursing in Virginia contingent upon her continued compliance with the HPMP.
- 6. Ms. Bradshaw entered the HPMP on August 25, 2016. After several evaluations, it was determined that Ms. Bradshaw had no current impairment diagnosis for monitoring. Accordingly, by letter dated February 15, 2017, the HPMP dismissed Ms. Bradshaw as ineligible for participation.
- 7. By Order entered October 18, 2016, the Alabama Board of Nursing accepted Ms. Bradshaw's voluntary surrender of her license to practice professional nursing in Alabama based on the aforementioned actions in Virginia and other States.
- 8. Pursuant to Virginia Code § 54.1-2409, by Order of the Virginia Department of Health Professions entered on May 16, 2017, Ms. Bradshaw's license to practice professional nursing in Virginia was suspended based on the action taken by the Alabama Board of Nursing on October 18, 2016.
- 9. The matter of reinstatement of Ms. Bradshaw's license to practice professional nursing in Virginia is properly before the Board.

### CONSENT

Sheri Randolph Bradshaw, R.N., by affixing her signature to this Consent Order, agrees to the following:

1. I have been advised to seek advice of counsel prior to signing this document;

2. I am fully aware that without my consent, no legal action can be taken against me or my

license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;

3. I acknowledge that I have the following rights, among others: the right to a formal

administrative hearing before the Board; the right to representation by counsel; and the right to cross-

examine witnesses against me;

4. I waive my right to a formal hearing;

5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my

right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in

any future judicial or administrative proceeding in which the Board is a party;

6. I consent to the entry of the following Order affecting my licensure to practice

professional nursing in the Commonwealth of Virginia.

**ORDER** 

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of

Nursing hereby ORDERS that the license of Sheri Randolph Bradshaw, R.N., to practice professional

nursing in Virginia is REINSTATED without restriction.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall

remain in the custody of the Department of Health Professions as a public record, and shall be made

available for public inspection and copying upon request.


