ORDER

JURISDICTION AND PROCEDURAL HISTORY

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), a Special Conference Committee of the Virginia Board of Nursing (“Board”) held an informal conference on August 17, 2016, in Henrico County, Virginia, to receive and act upon Sheri Randolph Bradshaw’s application for reinstatement of her license to practice professional nursing in the Commonwealth of Virginia.

Sheri Randolph Bradshaw appeared at this proceeding and was not represented by legal counsel.

NOTICE

By letter dated July 25, 2016, the Board of Nursing sent a Notice of Informal Conference (“Notice”) to Ms. Bradshaw notifying her that an informal conference would be held on August 17, 2016. The Notice was sent by certified and first class mail to the legal address of record on file with the Board of Nursing.

Upon consideration of the evidence, the Committee adopts the following Findings of Fact and Conclusions of Law and issues the Order contained herein.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Sheri Randolph Bradshaw was issued License Number 0001-179588 to practice professional nursing on July 9, 2002. Her primary state of residence is Virginia.

2. On December 3, 2014, Ms. Bradshaw submitted a written statement to the Board of Nursing voluntarily surrendering her license to practice professional nursing after her treating psychiatrist said she was unsafe to practice. On March 25, 2015, the Virginia Board of Nursing entered an order accepting the voluntary surrender of Ms. Bradshaw's professional nursing license for indefinite suspension.
3. Disciplinary action has been taken in other states in response to the VA BON order to indefinitely suspend Ms. Bradshaw's license.
4. Ms. Bradshaw submitted an application for reinstatement of her professional nursing license to the Board on February 1, 2016.
5. In January 2016, Ms. Bradshaw was diagnosed with bi-polar disorder in remission. Ms. Bradshaw's treating psychiatrist indicated in May 2016 that Ms. Bradshaw had stopped taking her prescribed medications. He said that she would need to be monitored and in treatment with a psychiatrist should her license be reinstated. Ms. Bradshaw indicated that she could not afford the mental health therapy because her health insurance had lapsed.
6. Ms. Bradshaw is relocating to Georgia for an employment opportunity with Armstrong University's Biology Department as an administrative assistant. This position will provide Ms. Bradshaw with health insurance.
7. During the informal conference, Ms. Bradshaw indicated that her support network consists of her mother, father, sister, stepmother, boyfriend, and her boyfriend's family.
8. Sheri Bradshaw has demonstrated satisfactory evidence that she is prepared to resume practice in a safe and competent manner.

ORDER


Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

1. The application of Sheri Randolph Bradshaw for reinstatement of her license to practice professional nursing is APPROVED contingent upon her entry into the Health Practitioners' Monitoring Program ("HPMP"). Thereafter, Sheri Randolph Bradshaw shall comply with the terms and conditions of the HPMP for the period specified by the HPMP.
2. Upon receipt of evidence of Sheri Randolph Bradshaw's participation in and successful completion of the terms specified by the HPMP, the Board, at its discretion, may waive Sheri Randolph Bradshaw's appearance before the Board and conduct an administrative review of this matter, at which time she may be issued an unrestricted license.
3. This Order is applicable to Sheri Randolph Bradshaw's multistate licensure privileges, if any, to practice professional nursing in the Commonwealth of Virginia. For the duration of this Order, Sheri Randolph Bradshaw shall not work outside of the Commonwealth of Virginia pursuant to a multistate licensure privilege without the written permission of the Virginia Board of Nursing and the Board of Nursing in the party state where she seeks to work. Any requests for out of state employment should be directed, in writing, to the Executive Director of the Board.
4. Sheri Randolph Bradshaw shall comply with all laws and regulations governing the practice of professional nursing in the Commonwealth of Virginia.
5. Any violation of the foregoing terms and conditions of this Order or any statute or regulation governing the practice of professional nursing shall constitute grounds for further disciplinary action.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.

Pursuant to Virginia Code § 54.1-2400.2(K), the Board considered whether to disclose or not disclose Ms. Bradshaw's health records or health services.

NOTICE OF RIGHT TO APPEAL

Pursuant to Virginia Code § 54.1-2400(10), Ms. Bradshaw may, not later than 5:00 p.m., on October 3, 2016, notify Jay Douglas, M.S.M., R.N., C.S.A.C., F.R.E., Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that she desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated. This Order shall become final on October 3, 2016, unless a request for a formal administrative hearing is received as described above.
