CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Chakietha Rena Johnson, as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Johnson's application for reinstatement of her certificate to practice as a nurse aide in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Chakietha Rena Johnson was issued Certificate Number 1401-061169 to practice as a nurse aide in Virginia on August 31, 2000. Said certificate expired on February 20, 2003. Ms. Johnson submitted an application for reinstatement of her certificate on December 27, 2016.
- 2. Ms. Johnson violated Virginia Code § 54.1-3007(4) in that on April 12, 2013, in the General District Court of the City of Roanoke, Virginia, she was convicted of petit larceny, a misdemeanor crime of moral turpitude. She was sentenced to 30 days incarceration, with 26 suspended, and ordered complete 16 hours of community service and to pay fines and costs.
 - 3. Ms. Johnson presented evidence that she has complied with the terms of her sentence.
 - 4. Ms. Johnson otherwise meets the requirements for reinstatement of her certificate.

CONSENT

Chakietha Rena Johnson, by affixing her signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;
 - I waive my right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my application for certification to practice as a nurse aide in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. The application of Chakietha Rena Johnson for reinstatement of her certificate to practice as a nurse aide in the Commonwealth of Virginia is APPROVED. Ms. Johnson shall be issued an unrestricted certificate.
 - Chakietha Rena Johnson is REPRIMANDED.
- 3. Chakietha Rena Johnson shall comply with all laws and regulations governing the practice of certified nurse aides in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
