CONSENT ORDER

JURISDICTION AND PROCEDURAL HISTORY

The Virginia Committee of the Joint Boards of Nursing and Medicine ("Committee of the Joint Boards") and Michael Quay Coggin, L.N.P., as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Mr. Coggin's license to practice as a nurse practitioner and authorization to prescribe in the Commonwealth of Virginia.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Michael Quay Coggin, L.N.P., was issued License Number 0024-172070 to practice as a nurse practitioner on September 18, 2014, which is scheduled to expire on March 31, 2018. Mr. Coggin was also issued Authorization to Prescribe Number 0017-141834 on September 18, 2014, which is scheduled to expire on March 31, 2018.
- 2. Mr. Coggin previously held License No. 244526 to practice professional nursing in North Carolina with multistate privilege, which expired on March 31, 2015. After the expiration of his North Carolina license, Mr. Coggin had no active license or multistate privilege to practice professional nursing.
- 3. Mr. Coggin violated Virginia Code §§ 54.1-3007(3), 54.1-3008(A)(2), and 54.1-3011(C) in that between April 1, 2015, and March 7, 2016, Mr. Coggin practiced as a nurse

that between April 1, 2015, and March 7, 2016, Mr. Coggin practiced as a nurse practitioner with Bon Secours Health System ("BSHS"), Richmond, Virginia, in the Commonwealth of Virginia without a valid nursing license.

- 4. Mr. Coggin was issued a license to practice as a professional nurse in the Commonwealth on March 8, 2016.
- 5. Mr. Coggin's employment with BSHS was terminated on March 15, 2016. He accepted responsibility for failing to ensure that his nursing license and nurse practitioner license were in good standing.

CONSENT

Michael Quay Coggin, L.N.P., by affixing his signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Committee of the Joint Boards; and the right to representation by counsel;
 - I waive my right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Committee of the Joint Boards is a party;
- 6. I consent to the entry of the following Order affecting my licensure to practice as a nurse practitioner and my authorization to prescribe in the Commonwealth of Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Committee of the Joint Boards hereby ORDERS as follows:

- 1. Michael Quay Coggin, L.N.P., is assessed a MONETARY PENALTY of \$250.00. This penalty shall be paid to the Board of Nursing by certified check or money order made payable to the Treasurer of Virginia within 90 days from the date of entry of this Order. Failure to pay the full monetary penalty by the due date may cause the matter to be sent for collection and constitutes grounds for an administrative proceeding and further discipline. Satisfaction of this term of this Order shall constitute satisfaction of Term No. 1 of the Consent Order of the Board of Nursing in Case No. 177601 affecting Mr. Coggin's license to practice professional nursing in the Commonwealth, License No. 0001-263722.
- 2. Mr. Coggin shall comply with all laws and regulations governing the practice of nurse practitioners in the Commonwealth of Virginia.
- 3. Any violation of the foregoing terms and conditions of this Order or any statute or regulation governing the practice of nurse practitioners shall constitute grounds for further disciplinary action.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
