CONSENT ORDER

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Da'Vaughn Christopher Dickerson submitted an application for certification by endorsement to practice as a nurse aide in the Commonwealth of Virginia on February 11, 2016.
- 2. Mr. Dickerson violated Virginia Code § 54.1-3007(4) in that on September 15, 2014, he was convicted of misdemeanor theft in the District Court for Dorchester County, Maryland.
 - Mr. Dickerson otherwise meets the requirements of Virginia Code § 54.1-3023. 3.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. Da'Vaughn Christopher Dickerson is REPRIMANDED.
- 2. The application of Mr. Dickerson for certification to practice as a nurse aide in the Commonwealth of Virginia is APPROVED. Mr. Dickerson shall be issued an unrestricted certificate to practice as a nurse aide in the Commonwealth of Virginia.
- 3. Mr. Dickerson shall comply with all laws and regulations governing the practice of certified nurse aides in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
