### CONSENT ORDER

# JURISDICTION AND PROCEDURAL HISTORY

The Virginia Board of Nursing ("Board") and Lauren Dawn Young, L.P.N., as evidenced by their signatures hereto, in lieu of proceeding to an informal conference, enter into the following Consent Order affecting Ms. Young's license to practice practical nursing in the Commonwealth of Virginia.

# FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. Lauren Dawn Young, L.P.N. was issued License Number 0002-094605 to practice practical nursing on September 29, 2016, which is scheduled to expire on March 31, 2019. Her primary state of residence is Virginia.
- 2. Ms. Young violated Virginia Code § 54.1-3007(4) in that on December 15, 2010, in the General District Court of Lancaster County, Virginia, she was convicted of petit larceny, a misdemeanor crime of moral turpitude.
- 3. Ms. Young violated Virginia Code § 54.1-3007(1) and 18 VAC 90-20-300(A)(1)(b) of the Regulations Governing the Practice of Nursing (currently found at 18 VAC 90-20-230(A)(1)(b) effective February 24, 2017) in that on her application for licensure to practice practical nursing, dated August 21, 2016, she falsely answered "no" to the question asking whether she had ever been convicted of a misdemeanor offense when, in fact, she had been convicted of petit larceny.

#### CONSENT

Lauren Dawn Young, L.P.N., by affixing her signature to this Consent Order, agrees to the following:

- 1. I have been advised to seek advice of counsel prior to signing this document;
- 2. I am fully aware that without my consent, no legal action can be taken against me or my license except pursuant to the Virginia Administrative Process Act, Virginia Code § 2.2-4000 et seq.;
- 3. I acknowledge that I have the following rights, among others: the right to an informal fact-finding conference before the Board; and the right to representation by counsel;
  - I waive my right to an informal conference;
- 5. I admit to the Findings of Fact and Conclusions of Law contained herein and waive my right to contest such Findings of Fact and Conclusions of Law and any sanction imposed hereunder in any future judicial or administrative proceeding in which the Board is a party;
- 6. I consent to the entry of the following Order affecting my license to practice practical nursing in the Commonwealth of Virginia.

#### ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Board of Nursing hereby ORDERS as follows:

- 1. Lauren Dawn Young, L.P.N., is REPRIMANDED.
- 2. Lauren Dawn Young, L.P.N., shall comply with all laws and regulations governing the practice of practical nursing in the Commonwealth of Virginia.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
