REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Nancy Durrett, R.N., M.S., serving

as Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal conference on

February 8, 2017 in Henrico County, Virginia, to inquire into evidence that Bryant Harris, C.N.A.,

may have violated certain laws and regulations governing the practice of nurse aides in the

Commonwealth of Virginia.

Mr. Harris did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

**Notice** 

By letter dated January 12, 2017, the Board sent a Notice of Informal Conference ("Notice") to

Mr. Harris notifying him that an informal conference would be held on February 8, 2017. The Notice

was sent by certified and first class mail to the legal address of record on file with the Board. The

receipt for the Notice sent via certified mail was signed by Mr. Bryant and returned to the Board office

on January 23, 2017. The Notice sent via first-class mail was not returned to the Board office

Accordingly, the Agency Subordinate concluded that adequate notice was provided to Mr. Harris and

the informal conference proceeded in his absence.

## Recommended Findings of Fact and Conclusions of Law

- 1. Bryant Harris, C.N.A., was issued Certificate Number 1401-126684 to practice as a nurse aide on October 16, 2008, which is scheduled to expire on October 31, 2017. At all times relevant to the findings herein, said certificate was in full force and effect.
- 2. Mr. Harris violated Virginia Code § 54.1-3007(2), (5), and (8) and 18 VAC 90-25-100(2)(e) of the Regulations Governing Certified Nurse Aides in that during the course of his employment with Golden Living Center, Portsmouth, Virginia, on September 15, 2015, Mr. Harris acted aggressively toward Resident A while trying to feed her, slammed her plate on the tray and temporarily denied her access to her beverage when she would not eat.
- 3. An alert and oriented resident witnessed the incident, which Mr. Harris continually denied. No patient harm occurred.
- 4. Mr. Harris' five-month employment with Golden Living Center was terminated following the September 2015 incident.
  - 5. Mr. Harris denied the allegation.
- 6. Mr. Harris violated Virginia Code § 54.1-3007(2) and 18 VAC 90-25-100(2)(d) of the Regulations Governing Certified Nurse Aides in that on his September 30, 2015, application for employment with Consulate Healthcare of Norfolk, Virginia, he failed to disclose his previous employments with and terminations from Golden Living Center and from Harbour Pointe Healthcare & Rehabilitation Center, Norfolk, Virginia.
- 7. Finding of Fact/Conclusion of Law No. 2 constitutes a Finding of Abuse pursuant to 42 CFR § 483.156(b)(2) and (c)(1)(iv)(D) of the Code of Federal Regulations.

## Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate recommends that the Board issue an Order as follows:

- 1. The certificate of Bryant Harris, C.N.A., to practice as a nurse aide in the Commonwealth of Virginia is REVOKED.
  - 2. The certificate of Bryant Harris, C.N.A., will be recorded as REVOKED.
- 3. A Finding of Abuse shall be ENTERED against Bryant Harris, C.N.A., in the Virginia Nurse Aide Registry pursuant to 42 CFR § 483.13(c)(1)(ii)(B) and 42 CFR § 483.156(b)(2) and (c)(1)(iv)(D). This finding prohibits Mr. Harris's employment as a certified nurse aide in any long-term care facility that receives Medicare or Medicaid reimbursement, according to 42 CFR § 483.13(c)(1)(ii)(B).
