REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Nancy Durrett, R.N., M.S., serving

as Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal conference on

February 8, 2017 in Henrico County, Virginia, to inquire into evidence that April Dawn Lawson,

C.N.A., may have violated certain laws and regulations governing the practice of nurse aides in the

Commonwealth of Virginia.

Ms. Lawson did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of

Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated January 11, 2017, the Board sent a Notice of Informal Conference ("Notice") to

Ms. Lawson notifying her that an informal conference would be held on February 8, 2017. The Notice

was sent by certified and first class mail to the legal address of record on file with the Board. Neither

the receipt for the Notice sent via certified mail nor the Notice sent via certified mail was returned to

the Board office. The Notice sent via first-class mail was not returned to the Board office.

Accordingly, the Agency Subordinate concluded that adequate notice was provided to Ms. Lawson and

the informal conference proceeded in her absence.

Recommended Findings of Fact and Conclusions of Law

- 1. April Dawn Lawson, C.N.A., was issued Certificate Number 1401-138614 to practice as a nurse aide on July 14, 2010, which expired on July 31, 2016.
- 2. Ms. Lawson violated Virginia Code § 54.1-3007(2), (5), and (8) and 18 VAC 90-25-100(2)(e) of the Regulations Governing Certified Nurse Aides in that during the course of her employment with Ridgecrest Manor Nursing and Rehabilitation, Duffield, Virginia, on November 17, 2015, Ms. Lawson spoke roughly to and directed profanity toward a resident, telling the resident to "sit down, you little bitch." Further, Ms. Lawson roughly handled the resident while transferring her to a cot, slamming her down onto it.
- 3. Three witnesses, including two members of an ambulance crew present to transport the resident, observed Ms. Lawson roughly handling the resident and cursing at her.
 - 4. The incident was investigated and substantiated by the Department of Social Services.
- 5. Ms. Lawson's employment with Ridgecrest Manor Nursing and Rehabilitation was terminated.
- 6. Ms. Lawson did not respond to any of the attempts by the investigator for the Department of Health Professions to contact her.
- 7. Finding of Fact/Conclusion of Law No. 2 constitutes a Finding of Abuse pursuant to 42 CFR § 483.156(b)(2) and (c)(1)(iv)(D) of the Code of Federal Regulations.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate recommends that the Board issue an Order as follows:

1. The right of April Dawn Lawson, C.N.A., to renew her certificate to practice as a nurse aide in the Commonwealth of Virginia is REVOKED.

- 2. The certificate of April Dawn Lawson, C.N.A., will be recorded as REVOKED.
- 3. A Finding of Abuse shall be ENTERED against April Dawn Lawson, C.N.A., in the Virginia Nurse Aide Registry pursuant to 42 CFR § 483.13(c)(1)(ii)(B) and 42 CFR § 483.156(b)(2) and (c)(1)(iv)(D). This finding prohibits Ms. Lawson's employment as a certified nurse aide in any long-term care facility that receives Medicare or Medicaid reimbursement, according to 42 CFR § 483.13(c)(1)(ii)(B).
