REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE

Jurisdiction and Procedural History

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Judith Piersall, R.N., B.S.N., serving as Agency Subordinate of the Virginia Board of Nursing ("Board"), held an informal conference on January 18, 2017 in Henrico County, Virginia, to inquire into evidence that Melissa Jane Arnold Jackson, L.P.N., may have violated certain laws and regulations governing the practice of nursing in the Commonwealth of Virginia.

Ms. Jackson did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of Fact and Conclusions of Law and recommends that the Board adopt the following Order.

Notice

By letter dated December 21, 2016, the Board sent a Notice of Informal Conference ("Notice") to Ms. Jackson notifying her that an informal conference would be held on January 18, 2017. The Notice was sent by certified and first class mail to the legal address of record on file with the Board. The Notice sent by certified mail was returned to the Board marked "unable to forward/return to sender." The Notice sent by first class mail was not returned to the Board office. Accordingly, the Agency Subordinate concluded that adequate notice was provided to Ms. Jackson and the informal conference proceeded in her absence.

Recommended Findings of Fact and Conclusions of Law

- 1. Melissa Jane Arnold Jackson, L.P.N., was issued License Number 0002-038401 to practice practical nursing on May 20, 1987, which expired on May 31, 2016. At all times relevant to the findings herein, said license was in full force and effect. Her primary state of residence is Virginia.
- 2. Melissa Jane Arnold Jackson, L.P.N., violated Virginia Code § 54.1-3007(6) in that she is unsafe to practice nursing due to mental illness and/or substance abuse, as evidenced by the following:
- a. Between March 2014 and December 2015, she was hospitalized six times, on an emergency basis, due to depression and alcohol intoxication. On one of those occasions, in December 2015, she acknowledged having consumed an excessive amount of tramadol (C-IV). While hospitalized, she acknowledged her history of alcohol abuse.
- b. On March 7, 2014, during the course of her employment as an administrative staff person with Albemarle Therapy Center, Charlottesville, Virginia, she appeared intoxicated while on duty.
- c. On May 23, 2016, in the Circuit Court of Greene County, Virginia, she was convicted of driving while intoxicated ("DWI") for an offense that occurred on December 8, 2015. On May 18, 2016, in the General District Court of Greene County, Virginia, she was convicted of DWI for an offense that occurred on April 20, 2016.
- 3. Ms. Jackson violated Virginia Code § 54.1-3007(4) in that on April 13, 2016, in the General District Court of Greene County, Virginia, she was convicted of shoplifting, a misdemeanor crime of moral turpitude.

4. Ms. Jackson did not respond to contact attempts by an investigator for the Department

of Health Professions. No current employment information was available.

5. Pursuant to Virginia Code § 54.1-2400.2(K), the Board considered whether to disclose

or not disclose Ms. Jackson's health records or health services.

Recommended Order

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate

recommends that the Board issue an Order as follows:

1. The right of Melissa Jane Arnold Jackson, L.P.N., to renew her license to practice

practical nursing in the Commonwealth of Virginia is INDEFINITELY SUSPENDED.

2. The license of Melissa Jane Arnold Jackson, L.P.N., will be recorded as SUSPENDED.

This suspension applies to any multistate privilege to practice professional nursing.

4. Should Melissa Jane Arnold Jackson, L.P.N., seek reinstatement of her license, an

administrative proceeding shall be convened to consider such application. At such time, the burden

shall be on Ms. Jackson to demonstrate that she is safe and competent to return to the practice of

practical nursing. Ms. Jackson shall be responsible for any fees that may be required for the

reinstatement and/or renewal of the license prior to issuance of the license to resume practice.
