RATIFICATION AND ORDER


On March 22, 2017, a panel of the Board met to receive and act upon the Recommended Decision of the Agency Subordinate. Mary Hortense Cook Goodman, C.N.A., was not present nor was she represented by legal counsel.

The Board of Nursing ACCEPTS the attached Recommended Findings of Fact and Conclusions of Law of the Agency Subordinate and ADOPTS the Recommended Order in its entirety.

Pursuant to Virginia Code § 54.1-2400.2, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.

Since Ms. Goodman failed to appear at the informal conference, this Order shall be considered final. Ms. Goodman has the right to appeal this Order directly to the appropriate Virginia circuit court. As provided by Rule 2A:2 of the Supreme Court of Virginia, Ms. Goodman has thirty days from the date of service (the date she actually received this decision or the date it was mailed to her, whichever occurred first) within which to appeal this decision by filing a Notice of Appeal with Jay Douglas, MSM, RN, CSAC, FRE, Executive Director, Board of Nursing, at Perimeter Center, 9960 Mayland Drive, Suite 300, Richmond, Virginia 23233. In the event that this decision is served by mail, three days are added to that period.

**REPORT AND RECOMMENDATION OF AGENCY SUBORDINATE**

---

**Jurisdiction and Procedural History**

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), Jane Elliott, R.N., Ph.D., serving as Agency Subordinate of the Virginia Board of Nursing (“Board”), held an informal conference on January 5, 2017 in Henrico County, Virginia, to inquire into evidence that Mary Hortense Cook Goodman, C.N.A., may have violated certain laws and regulations governing the practice of professional nursing in the Commonwealth of Virginia.

Ms. Goodman did not appear at this proceeding and was not represented by legal counsel.

Upon consideration of the evidence, the Agency Subordinate makes the following Findings of Fact and Conclusions of Law and recommends that the Board adopt the following Order.

**Notice**

By letter dated December 5, 2016, the Board sent a Notice of Informal Conference (“Notice”) to Ms. Goodman notifying her that an informal conference would be held on January 5, 2017. The Notice was sent by certified and first class mail to the legal address of record on file with the Board. The Notice sent by certified mail was not returned to the Board office. The Notice sent by first class mail was not returned to the Board office. Accordingly, the Agency Subordinate concluded that adequate notice was provided to Ms. Goodman and the informal conference proceeded in her absence.

### **Recommended Findings of Fact and Conclusions of Law**

1. Mary Hortense Cook Goodman, C.N.A., was issued Certificate Number 1401-048154 to practice as a certified nurse aide on November 19, 1994, which is scheduled to expire on November 30, 2017. At all times relevant to the findings herein, said certificate was in full force and effect.

2. Ms. Goodman violated Virginia Code § 54.1-3007(2), (5) and (8) and 18 VAC 90-25-100(2)(e) of the Regulations Governing Certified Nurse Aides in that on or about January 13, 2016, while on assignment with Beth Sholom Village, Virginia Beach, Virginia, she called Resident A a racial slur and threatened to throw him on the floor. When questioned by the investigator for the Department of Health Professions regarding this incident, Ms. Goodman admitted to using the “n” word, a racial slur. This constitutes a Finding of Abuse pursuant to 42 CFR § 483.156(b)(2) and (c)(1)(iv)(D) of the Code of Federal Regulations.

3. Ms. Goodman’s employment with Beth Sholom Village was terminated in January of 2016.

### **Recommended Order**

Based on the foregoing Findings of Fact and Conclusions of Law, the Agency Subordinate recommends that the Board issue an Order as follows:

1. The certificate of Mary Hortense Cook Goodman, C.N.A., to practice as a certified nurse aide in the Commonwealth of Virginia is REVOKED.

2. The certificate of Mary Hortense Cook Goodman, C.N.A., will be recorded as REVOKED.

3. A Finding of Abuse shall be ENTERED against Mary Hortense Cook Goodman, C.N.A., in the Virginia Nurse Aide Registry pursuant to 42 CFR § 483.13(c)(1)(ii)(B) and 42 CFR § 483.156(b)(2) and (c)(1)(iv)(D). This finding prohibits Ms. Goodman’s employment as a certified

nurse aide in any long-term care facility that receives Medicare or Medicaid reimbursement, according to 42 CFR § 483.13(c)(1)(ii)(B).
