FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Ebony Yvonne Easter, L.P.N. was issued License Number 0002-076599 to practice

practical nursing on August 27, 2007, which is scheduled to expire on September 30, 2017. Her

primary state of residence is Virginia.

2. Ms. Easter violated Virginia Code § 54.1-3007(2) and (5) and 18 VAC 90-20-

300(A)(2)(e) of the Regulations Governing the Practice of Nursing in that from August 21, 2015 until

February 26, 2016, during the course of her employment with Nursetek, Inc., Polk, Georgia, as a case

manager, Ms. Polk documented making visits to two clients when she had not actually done so. Ms.

Easter received payments for the fraudulent visits.

3. On April 13, 2016, Ms. Easter repaid Nursetek. Inc., \$2,250.00 for the salary that she

received for the fraudulent visits.

4. Ms. Easter resigned her position with Nursetek, Inc.
